

Discussion of the Regional Resourcing Grant

The Synod of British Columbia has access to \$61,641 for the year 2018, the same amount that was made available in 2016 and 2017!

In each year since 2014, The Synod of BC has divided the monies evenly between the 5 presbyteries. This year again (2018), each Presbytery made a successful application for the use of these funds. In addition the Synod Executive requested the balance of these funds and created a travel fund for rural and remote congregations. We are hoping to keep these funds available for next year's Synod gathering.

Again, here are some guidelines for applications:

There is a preference on the Life and Mission Agency to fund 'one time' or short term events or ministries such as retreats, conferences (presbyteries don't have to 'invent' a conference, but could, collectively attend an existing conference), summer ministries, camp staff etc.

Projects that are long term or ministries that are seeking interim funding for assistance to achieve a budget are not likely to be approved.

As a reminder, the Grant Review Committee accepts applications for this fund in the following format:

- 1. Name of Project
- 2. Outline of Project (including, vision, scope, goals and TIMELINE)
- 3. Budget
- 4. Beneficiaries of Project (locally)
- 5. Personnel involved in the project
- 6. Justification (what need is this project meeting in the local congregation, presbytery, Synod)
- 7. Extract of minutes from supporting Presbytery with relevant motion/details.

Minutes of the 125th Synod of BC

Friday Evening

Due to a storm the power in Richmond went out including at Richmond Presbyterian Church. This resulted in a delay to supper and many commissioners were delayed due to ferry and flight cancellations. The Open House presentations were incomplete due to delayed commissioners, but those presentations that were put up, were really appreciated. Eventually the power went back on and the supper was enjoyed by all those present. The business and opening worship began on time within the sanctuary.

6:45pm Business - Session # 1 - Sanctuary

Within the SANCTUARY of Richmond Presbyterian Church (RPC), the Moderator, the Reverend Dr. Cheol Soon Park constituted the court with prayer. He prayed for Geof Jay and Meridyth Robertson who were absent from the court due to a vehicle accident.

He welcomed Mary Fontaine, from Hummingbird Ministries, who addressed the court on behalf of the First Nations People and welcomed the members of the court onto the traditional lands of the Coast Salish people. She blessed the court with a traditional drumming ceremony.

The Stated Hour of 7:15 pm for the Service of Installation of the Moderator was noted.

Due to the vehicle accident the Reverend Geof Jay was not present to begin the Executive report. Martin Baxter presented the Executive Report on behalf of the Executive. Due to a ferry cancellation, Irwin Cunningham was not in the court either and Teresa Charlton agreed to second all the recommendations of the report.

The Moderator of the 124th Synod, The Reverend Dr. Cheol Soon Park opened the worship service for the Installation of the Moderator of the 125th Synod. The Chaplain, the Reverend Dr. Richard Topping preached the sermon, based on Acts chapter 10 (God shoes no favouritism). Richard preached on how the church is always catching up to God. The church does not set the mission. Instead we are charged with being converted to God's Mission.

At the conclusion of the service of installation the business of the 125th Synod scheduled for Friday evening continued at approximately 8:00pm, the Moderator, The Reverend Herb Hilder assumed the Moderator's chair and the Past Moderator, The Reverend Dr. Cheol Soon Park continued the presentation of the Executive Report.

Notice of Motion: In the minutes of the 124th Meeting of the Synod of BC within St. Andrew's, Nanaimo, a notice of motion was given by G. Jackson and J. Smith asking for clearer reporting of the *BC Building Fund, The Presbyterian Extension Fund and the Presbyterian Innovative Ministries Fund.*

In doing a little research into these funds the executive has discovered the following:

The Building Fund: This fund has been invested in the General Fund of the Synod within its portfolio with the Royal Bank. It is reported within the general assets of Royal Bank Dominion Securities. (page)

The Presbyterian Extension Fund (PEF) and *The Presbyterian Innovative Ministries Fund* (PIM) are wholly owned by the Presbyteries within the Synod, as shareholders. It is the opinion of the Executive that the Synod of BC, as a court, has no real jurisdiction over these funds and neither do we have authority to require reporting. Instead reporting of these funds should be made by request from the shareholders (ie. The Presbyteries).

David Jennings, one of the managers of the PEF and PIM has kindly given us information which has been circulated with the Executive Report.

It is the opinion of the Executive that no changes to the Standing Orders is required as these funds are either already being reported or are not under the direct jurisdiction of this court.

With the business completed the Moderator, The Reverend Herb Hilder adjourned the business meeting until Saturday, October 15th 2017 at 7pm. The Moderator prayed for the work of Synod and all the congregations which it serves.

Saturday Morning, October 15th

The Synod and guests opened the Synod Conference with worship led by the Synod Executive and with the Synod chaplain, The Reverend Dr. Richard Topping preaching the sermon, again from the Book of Acts.

The Reverend Ken Shigematsu was welcomed as Synod speaker. Ken shared that he grew up in two Presbyterian Church in Canada congregations: Whalley and Coquitlam churches. He shared that he grew up as a new Canadian and was grateful for his involvement in the church. His Dad grew up in the radio business and this planted a seed of broadcasting which became his sense of call to preach and lead.

Through the day Ken led the conference participants through a reflection on Psalm 127. In particular Ken emphasised verse 17:2

In vain you rise early and stay up late, toiling for food to eat— for God grants sleep to those he loves. In particular Ken reminded the conference that this verse can also be translated: In vain you rise early and stay up late, toiling for food to eat— *for while they sleep he provides for those he loves.* Ken reminded the conference that everything the church does should ideally start from a place of rest. We can have faith and trust that even while we rest God is working to bring about good things for those God loves. Often congregations and ministries forget that it is God who leads and is working ahead of us. Unless God builds it, we build in vain. The Hebrew Sabbath reminds us that the Jewish day starts at bedtime: it is by grace that we start the day with sleep, while God provides for us as we rest. A wonderful promise and an important reminder.

Ken preached in the afternoon about the church at Antioch as told in Acts 11. Ken emphasized that the church at Antioch was a very missional church (a sending church). It was Spirit led and helped out those in need through gifts sent through Paul and Barnabas. The conference members were invited to reflect on whether our congregations were typically in ward looking or outward looking.

The conference participants moved into small groups in the later afternoon. Though questions were prepared, there was a sense of sharing and fellowship within the groups that led the conversation in other directions.

In the last hour of the conference Ken answered questions about his ministry at 10th avenue Church, how much the congregation (just how) it had grown.
