Update

Over the past year, your interim minister had held "visioning meetings," with all interested people from the congregation. These meeting were well attended and the results were an agreed-upon Mission Statement and Vision for this congregation over the next 3-5 years. In order for this vision to be enacted, a structure needs to be in place to carry out the various components of our vision. The recommendations are that the following teams be designated to carry out the goals set out in the visioning process and that each team be comprised of three elders and up to five people from the congregation at large. These recommendations were approved by Session at their meeting on September 6th.

Worship & Music Team

While the minister is responsible for the conduct and content of worship, along with the supply of the pulpit, the session decides on the hours of worship and any special services, as well as the appointment of the organist and any other leaders of praise, whether voluntary of salaried. The team will also review the organist's contract yearly. **Responsibilities also include**: a greater variety of music included in the Sunday service, modernize the present worship service, provide opportunities for the congregation to share in Sunday services by reading scripture, sharing musical talents and greeting at the door, making youth feel a part of the service by taking communion and taking up the offering.

Pastoral Care Team

The duties of this team consist of recommending person for membership, baptism, transfer of membership to another church and restoring members whose membership has lapsed. The pastoral care team will also make sure there are elder's districts and when necessary recommend the addition of new elders. **Responsibilities also include**: education the congregation on the teaching of the Bible, visitation to all who may want contact, arrange drives for those who no longer drive, build up men's group and reach out to members and adherents who no longer attend.

Finance & Stewardship Team

The Session is responsible for all decisions relating to stewardship, including how and when the financial needs of the church at all levels, are to be presented to the congregation. They also work hand in hand with the Board of Managers. **Responsibilities also include:** increase church revenue, greater use of hall and sanctuary, explore all fund raising ideas, maintain church property, short & long term priorities and develop a plan to sustain the long-term life of our church congregation.

Congregational Life & Christian Education Team

The Session is responsible for providing for the program of Christian Education for persons of all ages in order that they may be confronted by the gospel, may grow in faith, participate in the life of the Christian community and be active witnesses to Christ in the world. **Responsibilities also include:** educate children in teaching of the Bible, offer Bible study one evening a month, provide regular classes from Sept – June with daily Bible School offered in the summer, combine with other congregations, expand Sunday School, reach out to youth, encourage grandparents to bring their grandchildren, hold a Saturday a.m. children's event and coffee house and social groups.

Mission, Outreach & Hospitality Team

The Session is to keep before the congregation, the life and work of the church around. the world and seeing that the congregation develops and maintains programs of mission and outreach, both related to its immediate community and beyond. **Responsibilities also include:** expand help to the hungry and homeless in conjunction with other churches, reach out to the public by advertising in printed and social media, special night with speakers, support seniors with pot luck, tea, rides, "Guess Who's Coming to Dinner" night, and encourage visitors to stay for coffee hour.

First/Kirk co-ordination Team

This team will work with the Kirk Church on matters of similar interest such as summer vacation time, congregational picnic, special services etc. **Responsibilities also include:** expand interaction with the Kirk, joint summer services and joint congregational picnic at Camp Geddie.

Please give prayerful consideration to joining any of these teams, so that we can move forward as a congregation. The Interim Minister may be visiting you to seek your help in serving on one of these teams.
