At New Life Rehabilitation Centre there is safety, shelter, medical care and food that is grown on site, but life remains difficult. Creating home and



Annual Congregational Meeting Minutes (February 25, 2018) 2018

The Annual Congregational Meeting of North Caradoc – St. Andrew's was held on February twenty fifth, in the year of our Lord twenty eighteen (February 25, 2018) at ten minutes past twelve o'clock noon (12:10 p.m.) within North Caradoc – St. Andrew's Presbyterian Church, Strathroy-Caradoc.

The Rev. Butterfield-Kocis stated that this meeting was an extension of worship so the meeting had been opened with the prayers and sermon in the series of the 'Story of Jonah' during this second week of Lent.

Sharon Peckham nominated Theresa Glithero to be recording secretary for this meeting. Theresa Glithero agreed to let her name stand. Sharon Peckham moved and Nancy Tomchick seconded the motion that Theresa Glithero be the recording secretary for this meeting. Carried.

It was moved by Charles Bolton and seconded by Wayne Gregory to adopt the agenda as printed with the addition of two (2) items in New Business: 1) Recommendation for Safe Place signage, and 2) 165th Anniversary celebration. Carried.

It was moved by Peter Evans and seconded by Angela Osborne to adopt the minutes of the Annual Congregational meeting of February twenty-sixth, twenty seventeen (February 26, 2017) as printed and included in the twenty seventeen (2017) annual report. Carried. There was no business arising from the minutes.

The following reports were received with any questions or comments entertained: Minister's Message and Session Report. The Rev. Butterfield-Kocis noted that the term for elders Wayne Gregory and Angela Osborne is in the final year. They both have been asked to consider a second term. The congregation was asked to prayerfully consider electing at least one (1) new elder this year.

The presentation of reports continued: Pre Authorized Remittance (PAR) Report, Ladies' Aid Annual Report, Memoriam Bank Account and 'In Remembrance' Book Report, Youth Bank Account, and "Countdown to Christmas" Bazaar. There is no convener for the November seventeenth (November 17th) bazaar and the congregation was asked to prayerfully consider becoming a convener or co-convener for this event.

The Board of Managers' Report and Trustee Report were received.

It was moved by Barb Bolton and seconded by Darrell McComb to accept the reports as printed and circulated. Carried.

The Rev. Butterfield-Kocis verbally gave the Christian Education report. She stated that the Holy Moly and ECHO Youth programs have been supported. Bible studies are offered on a regular basis. Also this summer, August thirteenth to seventeenth, twenty eighteen (August 13-17, 2018), Kintail on the Road (KOTR) will offer a culinary Vacation Bible School at North Caradoc – St. Andrew's. Volunteers will be needed.

The Auditor's Report was read, as it was not included in the bound copy of the Annual Report for 2017. A motion to accept this report will be included with the Budget.

Joanne Grivich and Brian Huston presented the Profit and Loss Statement of 2017 and the Draft Operating 2018 Budget. It was noted that there was a 1.5% increase to salary/stipend forpersonnel and minister. It was also noted that Session recommended that the accepted allocation for Presbyterians Sharing be six thousand dollars (\$6,000). It was moved by Joanne Grivich and seconded by Larry Langford to accept the Auditors Report and the Financial Documents as printed noting that the figures for Presbytery Dues and Synod Allocations and Health and Dental had been corrected. Carried. Brian Huston indicated that it is anticipated that North Caradoc – St. Andrew's will produce offering envelopes in house with a substantial savings realized.

Larry Langford moved to adjourn for lunch and reconvene approximately one fifteen o'clock in the afternoon (1:15 pm.)

The meeting reconvened at twenty-five minutes past one o'clock in the afternoon (1:25 p.m.).

The slate of Board of Managers for twenty eighteen (2018) was reviewed. Charlotte Gregory nominated Wayne Gregory to be a member of the Board of Managers. Wayne Gregory accepted the nomination. Janet Evans moved and Sharon Peckham seconded the motion to appoint Bob Gillies, Charlotte Gregory, Joanne Grivich, Peter Grivich, Brian Huston, Darrell McComb, Janet McGugan, Shane MacLeod, Jan Salomons, Dan Walker and Wayne Gregory as members of the Board of Managers for twenty eighteen (2018). Carried.

The Rev Butterfield-Kocis stated that it is a concern that Doug Cudney has not been active in the faith community, yet sits as a Trustee. With the knowledge from the report that trustee decisions will be made this upcoming year, it was moved by Wayne Gregory and seconded by Peter Grivich that the congregation give power to the joint Board and Session to speak with Doug Cudney about his intentions and possible retirement from the Trustees, and then seeking a new Trustee. Carried

It was moved by Charlotte Gregory and seconded by Bonnie Salomons to appoint Sharon Peckham and Wilma Reath as auditors for twenty eighteen (2018), Carried,

Theresa Glithero stated that Session would like to recommend that signage is posted prominently within the church building, in bulletins/newsletters, on North Caradoc – St. Andrew's website and in eNews and outdoor church signs that our faith community is a safe place for everyone no matter race, religion or sexual identity. Peter Grivich moved and Wayne Gregory seconded the motion saying that the posting would state 'North Caradoc – St. Andrew's is a safe place where diversity is valued, everyone is welcome here in our community no matter race, religion or sexual identify'. After discussion, it was agreed to change the wording of the original posting to read 'North Caradoc – St. Andrew's is a safe place where diversity is valued and all are welcome'. The original mover and seconder agreed with the change in wording. Carried.

North Caradoc – St. Andrew's will celebrate the 165th Anniversary in May and the congregation was asked to present any ideas for this celebration to the Rev. Butterfield-Kocis or session member by March twentieth (March 20th).

It was moved by Lily Carrothers and seconded by Angela Osborne to hold next year's annual general meeting February twenty fourth, twenty nineteen (February 24, 2019). Carried.

Angela Osborne motioned to adjourn. The Rev. Butterfield-Kocis closed the meeting with prayer and the benediction.

Session expresses heartfelt thanks to The Rev. Michelle Butterfield-Kocis for her inspiring messages each week and special services and her commitment to the congregation's faith journey. It is a task that she embraces enthusiastically.

It is with regret that the six-year term of office of elder Angela Osborne and Wayne Gregory was completed. Elder Angela Osborne decided not to extend her term while Wayne Gregory was willing to extend his term. Thank you so much Angela for your diligence to your districts during your term as elder. Her commitment was recognized during a worship service in the fall.

The congregation was asked to nominate potential elders and it is with gratitude that on October fourteenth (October 14th) Grant Corey and Jamie Hayter were ordained, Elizabeth Leitch was inducted and Wayne Gregory was admitted as ruling elders of North Caradoc – St. Andrew's.

E-News is published on a regular basis. Thank you Rev. Shelly for your work on this publication. This keeps everyone informed of upcoming events at both North Caradoc – St. Andrew's and Knox, Komoka.

There were six (6) Holy Communion worship services during the year with an average of 44 members and friends coming to the table to be fed. These services were held the first Sunday of Lent, Maundy Thursday, joint worship in July, Worldwide Communion in October, first Sunday in Advent and candlelight Christmas Eve at 11:15 p.m. As well Rev. Shelly and an elder took communion to shut-ins throughout the year.

We congratulate the Rev. Ferenc (Frank) Szatmari, minister at Calvin Presbyterian Church in Kitchener on earning a Doctor of Ministry degree from Knox, College, University of Toronto. The Rev. Szatmari leads the Hungarian speaking worship service at North Caradoc – St. Andrew's on a regular basis. There were three (3) Holy Communion worship services during the year with an average of twenty (20) members and friends coming to the table to be fed. These were held in May, October and December.

The congregation mourns the passing of Joseph Drabbant, Cathy Dobrenty and Sylvia Hodnett. Family and friends will miss them.

The congregation celebrated the baptism of William Grant Blackburn, son of Erin and Ryan Blackburn and grandson of Grant and Anne Marie Corey. Welcome William.

The Rev. Butterfield-Kocis performed two weddings this past year. Jeff Mendham and Jenna Stewart were married in Stratford in June. Jenna's parents attend Knox, Komoka. Stephane Gregory and Connie Blair were married in September in Toronto. We wish both newlyweds much happiness.

It was with regret that Gord and Diana McAuslan transferred their membership to Mt. Brydges United Church. It was also with regret that Christin Gillard asked that her membership be removed.

Another very successful Countdown to Christmas bazaar was held in November. Thank you to coconveners Lily Carrothers and Carol Huston. Fresh cabbage rolls, frozen meat pies, tables full of baking and canning were offered to waiting buyers. These sold out very quickly. The porch signs, lighted Christmas decorations and string art and other crafts were sold to excited recipients. Ticket sale proceeds from the gift baskets were donated to the Caring Cupboard in Mt. Brydges. Thank you to everyone for their ongoing commitment to this fundraiser.

North Caradoc – St. Andrew's is 'home' to many community groups. The ukulele group – CRACKERS – meets once a week as well as yoga participants meeting twice weekly. CRACKERS hosted a concert Saturday November 24th culminating with a hot bowl of soup and crackers and fellowship. All proceeds of the free will offering and donated food was presented to the Caring Cupboard, Mt. Brydges.

A book club is also very active and meets monthly usually in the home of one of the members. The genre of the books varies but all inspire thoughtful discussion.

Session is pleased that new signage was erected inside the church building as well as on the two signs outside – one on the church grounds and the second one on the large sign at the corner of Adelaide Road (#81 highway) and Scotchmere Drive. The signs state that North Caradoc – St. Andrew's is a safe place where diversity is welcome.

A group of dedicated people forms the Prayer Team. Thank you to the members of the team for this meaningful ministry. However, many in the congregation are honorary team members. Prayer doesn't only mean intentional prayers. Hugging a friend, taking food to someone in need, helping someone by giving time and energy and other acts of kindness are prayers. Prayer is the voice of love, friendship and genuine caring. North Caradoc – St. Andrew's is a praying congregation.

Rev. Shelly held a couple of Bible studies throughout the year. The first was a Lenten Bible study entitled 'Journeys with Celtic Christians' by Rodney Newman. The second began in the summer, Back Deck study and continued into the fall studying 1 Corinthians using Max Lucado's book as a guide. There were also Lenten Spirituality activities available to anyone wishing to participate.

North Caradoc – St. Andrew's hosted a full day Kintail on the Road Culinary Vacation Bible Study for 39 enthusiastic campers August 13-17. Thank you to all the volunteers and the three Kintail leaders – Solis (Lindsay), Pantera (Oswaldo) and Kaede (Darby) making this so enjoyable to the campers. The campers were excited to learn biblical lessons and songs as well as bake. They received their own apron, cookbook, and spatula and learned many songs that I know were sung months after the program finished. Adults were invited to the Friday afternoon culminating program listening to songs learned and taste the many things that were baked.

A potluck supper was held before the Maundy Thursday worship service. There was also a potluck supper early in December to begin the Christmas season. The congregational picnic was held in June. There is never a shortage or variety of dishes presented at any of these events and everything is always yummy.

North Caradoc – St. Andrew's celebrated its 165th anniversary in May with special music provided by the Amabile Boys Choir ensemble followed by a tasty lunch. A congregational picture was taken thanks to Lauren Huston. The picture of this celebration was submitted to the Presbyterian Connection and was featured in the fall edition. What a good-looking group!

The annual pig and corn roast was held in August at the McGugan farm. This event is a highlight for many congregation and community members. Friendships are renewed and new ones made all the while enjoying the music provided and the tasty food. The organizers and volunteers are to be commended for making this an enjoyable and well-attended event.

Joint worship with Knox, Komoka was held over the summer months – July at Knox, Komoka and August at North Caradoc – St. Andrew's. As well, on Christmas Sunday (December 23rd) North Caradoc – St. Andrew's hosted the Knox congregation and on December 30th, Knox hosted the congregation of North Caradoc – St. Andrew's. These joint worship services provide fellowship opportunities with our sister charge.

Session wishes to thank the many who work tirelessly and share in the leadership of the day-to-day operation of the church. We thank Holy Moly teachers, those who fill the sanctuary with music, those who organize fundraisers and fun activities, those who visit the sick and shut ins, those who provide snacks and clean up after worship during fellowship time, those who ensure ice and snow is removed in the winter and grounds well maintained in the summer, those who keep the sanctuary warm for worship and for the many events held during the week, those who uphold many in prayer, those who prepare electronic and paper bulletins, those who keep the finances in order, those who decorate inside and out and all those who contribute their time and talents in ways too numerous to print. North Caradoc – St. Andrew's is a very active and vibrant congregation and supports numerous worthwhile causes in the community and world. Session is humbled by the many who serve our Lord willingly and cheerfully without any needed recognition. Each member, whether mentioned or not, is vital to the well-being of North Caradoc – St. Andrew's providing a safe, welcoming atmosphere for all who enter.

We give thanks to God for His continued presence as we grow in faith and reach out to spread the Word into the community honouring His name. We also express gratitude to the congregation for their ongoing support, faithful attendance and prayers this past year.

With the rising trend in interest rates and 5 investments maturing during 2018 we were able to increase the combined returns on our investments from 1.91% to 2.56%, an annual increase of \$1 970.

The "Accumulated Approved Transfers", the balance of "Advancing the Mission Fund" and "Share of the Minister's Manse Allowance" is retained by the Trustees for higher earnings. There was a request for the Trustees to support the operations of the church during 2018 and \$3 500 was transferred leaving a balance of \$7 907.

A note to Special Rate #023. The invested principal dropped from \$51 870 to \$50 000 due to the fact that this was a 3 year compounding investment where only the principal was reinvested and the interest earned deposited in Savings Account #003.

- Canadian Ministries gave 28 grants worth \$1,254,194 to support ministries across Canada.
- **International Ministries** supported 15 mission staff and 9 leadership development students. 2 young adults were sent for short-term mission placements – Amy Zavitz to Israel/Palestine and Stephanie Chunoo to Kalunba in Budapest, Hungary. \$309,850 supported partners in Bible translation, Christian education, leadership development, theological education and evangelism.
- The **Presbyterian Connection** newspaper has a distribution of 16,500 and growing; the PCConnect e-newsletter reaches 2,050 subscribers and the PCC's Facebook page has 2,438 fans.
- Canada Youth brought together 365 participants with representatives from each synod. 18 international youth from Ghana, Taiwan, Malawi and Lebanon were also welcomed into the community.
- The Guidance Conference supported 14 ministry candidates; 15 students graduated from our theological colleges and 13 ministers were ordained and placed into ministries. \$2,765 was awarded in Continuing Education grants.

- **Letters were sent** to the Government of Canada on the opioid crisis, the prohibition of nuclear weapons, and to harmonize Canada's laws with the United Nations Declaration on the Rights of Indigenous Peoples.
- Archives serves over 3,000 individuals each year with its collection of 40,000 photographs and 4 million pages of records. An online exhibit on Residential Schools was launched in 2018.
- The PCC hosts and supports over 320 websites on behalf of congregations, specialized ministries, camps, presbyteries and more.
- 227 commissioners, 3 student delegates and 18 youth delegates from across the country gathered and made decisions at the **144th General Assembly** in June.
