#### **MEMORIAL SERVICE**

The Clerk read the following memorial of a Minister who had died since the 2014 Synod meeting:

Rev. Dr. Murdock J. MacRae, Murdock passed away on August 14, 2015 with his family at his side. He was born in Wreck Cove, Cape Breton, graduated from Acadia University and the Presbyterian College in Montreal. He served his forty years in ministry in the Presbytery of Cape Breton being minister at St. James Big Bras d'Or and Knox Ross Ferry, St. Giles PC North Sydney, and in his retirement he served the Grand River Pastoral Charge part-time. Serving on many Synod and Presbytery Committees, he also gave of his time to serving in his community. A gifted carpenter and craftsman, various churches in the Synod have benefited from his talent in items he built and donated. He leaves behind his wife of fifty-two years, Ruth, three children, six grandsons and two great-grand children. His memorial service was held in St. Giles PC on August 19, 2015. The Presbytery of Cape Breton has lost a mentor, a worker and a dear friend.

The Clerk read the following memorials of Ruling Elders who have died since the 2014 Synod meeting:

**Mr. John A. Kerr,** died 1 November 2013 (age 92). After his family, John's first love was his beloved St. Andrew's PC, North River, where he was a very active and a generous supporter of all aspects of the church's life and mission. He was an active elder for 29 years and a member of the choir for 50 years.

**W. T. MacAulay,** passed away October 24, 2014. William Thompson MacAulay was ordained as an Elder of the Presbyterian Church on May 27, 1962 and since that time has served the church diligently until his passing on October 24, 2014. Toss served his church as a member of the Men's Choir and Senior Choir, he organized and contributed to many Anniversary Services over the years. His wisdom was appreciated as he took part in discussion of many matters which came before Session, and has been a strong outreach to those in his Elder's District. Toss served both his church and his country, having served overseas as a member of the Armed Forces, and he was an active member of the local Legion.

Mr. Jack Stagg, a member of St. Giles PC North Sydney since 1938, died November 12, 2014 at the age of 93. Jack was elected an Elder in 1976 and served faithfully in that capacity as well as on the Board of Managers. He was a member of the choir for over fifty years and a member of the St. Giles Quartet. His presence is missed by all at St. Giles.

**Gerald Hayman Reid,** 91 died on November 24, 2014. Gerald served faithfully as an elder of First Church, Stellarton for over 53 years. He worked for the Power Board for 38 years. A kind and gentle man, his honesty and industry were only outweighed by his love of God, the Church of Jesus Christ and his wonderful family. He always offered friends and strangers alike a kind and generous welcome to the church. His presence is deeply missed. He is survived by his wife, Isabel, sons Gerald and Philip and daughter Sheila.

Robert (Bob) Nelson Scott (1933-2014) Born in Saint John, NB, Robert (Bob) Nelson Scott was a professor of electrical engineering who founded the University of New Brunswick's Institute of Biomedical Engineering, which achieved world leadership in development of electronic control systems for artificial limbs. For many years, Bob was an active member of St. Andrew's Presbyterian Church in Fredericton and in 1972 was ordained as an elder. He would later serve many years as organist and elder at St. James Presbyterian Church in Hanwell. On November 4, 2013, St. James Presbyterian Church granted Bob the designation Elder Emeritus. Bob also served one term as moderator of the former Presbytery of St. John. Bob died on December 22, 2014.

**Dr. Andy den Otter**, He has faithfully served St. David's Church as a Ruling Elder for many years, and often would take the service and speak when the Minister was away. He has faithfully served the Presbytery of Newfoundland as Moderator from 1999 to the end of December 2014. He also served as Moderator in the Atlantic Synod in 2012. He used his skills as a Historian throughout his service to the Church and especially in the national church on the History Committee, and also served on the Life and Mission Agency. He willingly and positively took up all the positions in the many Committees in which he served throughout his working career and into his retirement. He also served in ecumenical groups such as the St. John's and Area Council of Churches, where he served as Secretary. Andy brought grace and a strong conviction to all that he undertook. It is a tribute to him that many within his family also serve the Church in leadership positions.

**Earle Patterson,** a devoted member of Knox Presbyterian Church, Harvey Station, N.B. passed away on January 11, 2015. Earle was an Elder for many years and was given the designation of Elder Emeritus in 2007. He enjoyed being with his family, bowling, going for drives and fish and chips. His presence has been missed by his church family and community.

Carole Christine Trites, Hantsport, N.S. was ordained as an elder in St. John's Presbyterian Church, Windsor, N.S. on November 24, 1996. She served faithfully until her death 18 years later on January 21, 2015 at age 75. Carole was a woman of deep faith who devoted her life to her family and over a 55-year career in the nursing profession. She will be deeply missed.

**Mr. Roy Kerr,** died 26 February 2015 (age 70). Elder at St. Andrew's PC North River for 18 years (1995-2013) and Clerk of Session for 11 years (1999-2010). Roy's quiet, firm leadership helped to successfully guide the congregation through the amalgamation of four churches. He was also a highly valued member of the Board of Managers for many years.

James William Paynter, died March 3, 2015. James was ordained as an Elder at Summerside Presbyterian Church in 1983 and served on Session until 2008. During his time on Session, he was a member of the Nurture Committee and the Leading with Care Committee and when his term as a member of Session was completed, he continued to be active as a Pastoral Care visitor. He was a very willing volunteer and a "people-person", a gift which earned him the title of "SPC greeter".

**Hugh Sharkey,** died on April 23, 2015. He was a well-loved, dedicated elder of Kings Church, New Minas, where both he and his wife, Betty, played key roles on session during the early establishment of the congregation. Born in Glasgow, Scotland, High emigrated to Canada following the Second World War and was active for many years in Mimico Presbyterian Church (Toronto) before retiring to the Annapolis Valley in 1990. For many years Hugh served faithfully at the Fundy Inter-Church Food Bank in New Minas.

**Ralph Shaw,** passed away May 11, 2015. Ralph served the congregation of Bethel Church, Sydney from the time he became a member, contributing to the Sunday School and Youth Group and later as an Elder of Bethel. Ralph's presentation of Scripture was always a lesson in itself as he explained the setting of the verses, often including his own experiences traveling in the Holy Land. His contributions were always greatly appreciated until he moved to Ontario to be with family.

**Mr. Chris Corkum,** an Elder in St. Andrew's Presbyterian Church, Lunenburg for 39 years; passed away on May 17, 2015 at the age of 69. He was active in his church and community and had served as Church School Superintendent for a number of years.

Olive Ruth Clark, age 82 of Halifax passed away peacefully on Tuesday, May 19, 2015. Olive was employed by Great West Life and later with Immigration Canada, retiring after 22 years of service. She served faithfully and well for many years on the Session of the Presbyterian Church of Saint David.

**Wade Smith,** age 68 died on June 27th, 2015. A long-time resident of Hopewell, NS he was a member of First Presbyterian Church Choir, Chairman of the Board of Managers and member of Session of First Presbyterian Church. Mr. Smith also sang with the Stellarton Male Choir, Barber Shoppers and other groups. He worked incredibly hard in all his endeavours and lives with a passion for God, family and friends. He will always be remembered for his "never give up" personality.

**Robert Grant Mollison,** died July 29, 2015. Grant was ordained as an Elder at Summerside Presbyterian Church in 1993 and served as a member of Session until 1998, when poor health necessitated his resignation. Prior to being a member of Session he was active in the work of the Board of Managers. Grant served in a quiet, unassuming manner and had a smile for everyone.

**Karen Elizabeth Moores,** 1955-2015 Karen passed away suddenly on Sunday March 8th at the age of 59. At the time of her passing, Karen was Clerk of Session at St. Andrew's, following in the footsteps of her grandfather and her father. Professionally Karen was a well-respected Social Worker and willingly gave her time and talent to philanthropic outreach organizations, Karen served on the Board of Bridges to Hope Food Aid Centre (An outreach of the Presbyterian and United Churches in St. John's) becoming Chair of the Board. Karen will be missed.

William Elton, March 6, 1935-June 19, 2015 Bill was a member of the Board of Managers, a faithful Elder, former Boy Scout Leader, generous contributor St. Andrew's, St. John's, Nfld. Bill was the Owner of Colonial Garage and Distributors and was known as" Mr. Bill" by all of his employees. He was very successful in business, respected by all; and everyone knew he belonged to the Kirk. Even in the past year as his health deteriorated; he insisted on being kept up to date on "Church News." Bill's family continue his legacy. Bill is survived by his wife Faith, two daughters and their families. His passing has left a void in our "Church Family".

John Peters Henderson died June 29, 2015. John Henderson was an active member of St. Andrew's Church, St. John's, becoming an Elder in 1959 at the age of 32. He was a member of the Presbytery of Newfoundland, holding the office of Treasurer. He was Representative Elder and attended Synod in that role many times. In his professional life John was an engineer - first with Montreal Engineering, then NL Light &Power and finishing his career with NL Hydro. Always involved in all aspects of Kirk life; John will be remembered for his gentle presence and dependability. John is survived by his wife Faith, five sons and their families.

John A MacDonald passed away July 28, 2015. John MacDonald served Bethel Church, Sydney throughout his life, including playing an active role in Youth Group. John was ordained as an Elder in nineteen hundred and ninety-four (1994) and served on many Session Committees, as well as serving as Bethel's Representative Elder, and he served as Moderator of Presbytery of Cape Breton for a term. John also served the Congregation as Secretary and then Convenor of the Board of Managers. His dedication to the Congregation and the Denomination was greatly appreciated and valued by all who worked with him in serving God.

**Dr. Carl MacDonald,** died 10 August 2015 (age 79). Elder at St. Andrew's PC North River for 4 years (2006-2010), choir member since retiring to North River in 1995, also served on Board of Managers. His many years of experience as a physician translated into compassionate care and understanding for members of the congregation and he was affectionately known for his "choir room clinic."

Honourable John McNab (Jack) Davison (1935-2015) died on September 1st, 2015 at the age of 79. Jack was appointed a Justice of The Supreme Court of Nova Scotia, Trial Division in March, 1987 and remained on the bench until his retirement in 2008. He retired as an elder of the Presbyterian Church of Saint David in 2001.

**Dr. John Paul Schaefer** died October 2, 2015. Paul was ordained as an Elder at Summerside Presbyterian Church in 1977 and he served as a member of Session until 2004. Paul had a heart for mission and for helping anyone who needed assistance of any kind. This was evidenced in his professional life as he made many trips to Canada's far North, offering his services as a surgeon even after his official retirement. Paul was a member of the church choir and he will be remembered for his sense of humour and for his enthusiastic and generous support of the mission and ministries of the church.

The members of the court sang "O saints in splendour sing."

The Moderator led the court in a prayer of thanksgiving and commemoration.

The Moderator declared the Rev. Jeff Lackie elected as Moderator for the 142<sup>nd</sup> meeting of the Synod of the Atlantic Provinces.

# SECOND SEDERUNT - TUESDAY, OCTOBER 20, 2015, 9:30 A.M.

At Moncton, New Brunswick, at St. Andrew's Presbyterian Church on Tuesday the twentieth day of October in the year of our Lord two thousand and fifteen, at nine-thirty in the morning, the Synod of the Atlantic Provinces met for the second sederunt of its annual meeting.

#### **WORSHIP**

The gathering of Synod began with worship led by the Rev. Marion Barclay MacKay

#### **CONSTITUTION**

The Moderator called the court to order at 9:30 am and led in prayer.

#### **GUEST SPEAKER**

The Moderator called upon T. Archibald to introduce The Rev. Dr. Graham Standish.

Dr. Standish is pastor of Calvin Presbyterian Church in Zelienople, Pennsylvania. He has a background as a therapist in a psychiatric hospital, as a therapist in a pastoral counseling agency, as a drug and alcohol therapist, and an internship as a hospital chaplain. He holds a Ph.D. in formative spirituality from Duquesne University, a Master of Social Work from the University of Pittsburgh, and a Master of Divinity is from Pittsburgh Theological Seminary. Dr. Standish is an adjunct professor at Pittsburgh Theological Seminary Doctor of Ministry Program and Certificate in Spiritual Formation Program, and at Tyndale Theological Seminary in Toronto, Ontario, focusing in the areas of spirituality and congregational leadership.

Dr. Standish identified a common contrast in the choice of guest speakers. In Presbyterian circles we invite those who have studied those who do something. In American Evangelical circles they tend to choose "the doers themselves." He spoke from his studies and practice at Calvin Presbyterian Church, Zelienople, PA.

In Calvin, the primary congregation he serves, he traced a series of transformations with a focus on grounding the life of the church in prayer and discernment. One of his books, Becoming a Blessed Church, describes how congregations can be transformed by becoming more open to the Holy Spirit. "God, what are you calling us to do to reach out to the people you are calling us to reach out to?"

In the tradition of "decently and in good order" we were challenged to get back to the Biblical model, to that deeply rooted openness to the Spirit as in Acts 2. Moving beyond "formal religion," we were challenged to

learn again how to "be a Hebrew to the Hebrews, a Greek to the Greek, a slave to the slave." (1 Corinthians 9:19-22) What is God calling us to do?"

Highlighting the theories of Fr. Adrian van Kaam, Dr. Standish identified a four quadrant paradigm of the dimensions of life: 1. Spiritual (Our aspirations to connect with that which is beyond us), 2. Mental (the function of organizing and giving order (theology), 3. Physical (how we embody the spiritual and the mental for example in art and symbol), and 4. Relational (how we connect to all around us). "You cannot be spiritual alone." "The spiritual is organized by the mental, manifested by the physical, and comes alive with the relational dimension."

Standish suggested that in the North American culture we have cut off the spiritual dimension. This is too easily true in our churches. When the mental dimension dominates, then gaining and wielding power become central in the life. It makes us rigid about change. We want to maintain what has always been. When the physical dominates our focus becomes satisfying desires and urges. In churches this is expressed in a preoccupation of looking perfect with nothing out of place. When the relational dimension dominates we no longer develop our own individual personality.

Dr. Standish closed with some provocative questions. We were asked to reflect on what dimensions of life are most dominant in our churches and what can we do about it? To what extent in our church and personal life is discerning what God is calling us to do? How do we make decisions?

## THIRD SEDERUNT- TUESDAY, OCTOBER 20, 2015, 1:30 PM

At Moncton, New Brunswick at St. Andrew's Presbyterian Church on Tuesday the twentieth day of October in the year of our Lord two thousand and fifteen, at one-thirty in the afternoon, the Synod of the Atlantic Provinces met for the third sederunt of its annual meeting.

#### **GUEST SPEAKER:**

The Moderator invited Dr. Graham Standish to address the court.

His second address focused on two questions: How do we transform how we make decisions in our churches? How do we transform those who make decisions?

For those who are close to God and God centered, the significant question is "God, I know you are out there, What is your call to me?" This can be distinct from analysis or the taking things apart to see what is wrong. Discernment is more like "panning for gold." Discernment involves sifting through all the possibilities you can imagine to identify together the direction God would have us go. Discernment can identify initial steps that might be part of the journey. When you start in a direction, things can fall in place.

Discernment is built on the belief that God directs. The key to discernment is to believe and see, believe and you will hear. The early church discerned. "The contemporary church analyzes, debates, and deliberates." How to discern? It is a matter of sifting through possibilities.

Everything in discernment is subjectivity but it includes prayer, and it is prayer that keeps us connected. Objectivity is the language of analysis. Discernment admits subjectivity but I will do this prayerfully with the belief that God can direct me in prayer. You keep asking if this is what God wants each step of the way. Failure directs us to consider other possibilities.

You talk to others. You cannot discern by yourself. Discernment is communal and complex. He pointed to the Dialogical discernment (Hegelian dialectic: thesis (idea), antithesis(new idea), synthesis (if you stay in the

clash long enough you will develop a hybrid). In communal discernment, God is in the thesis, in the antithesis, and the synthesis. God is in the clash –then you listen to one another as part of listening to God. Listen for a possibility even in the person who is just trying to stop a possibility. In discernment you ask people to step outside of themselves to seek what God would have us do.

Dr. Standish provided examples of practice and patterns of discernment agendas for his Sessions and Presbytery. He noted that the goal is not majority decision but consensus. "If we come to roadblocks, we pray." He noted the challenge and importance of teaching leaders to be not only functional but spiritual in their participation. Choice of leadership gives priority to the question "Is this someone who is committed to seeking God's will?"

He suggested the following seven basic principles of leadership in developing discernment:

- 1. In every meeting take time (silence) for centering so that leaders can listen for God's voice.
- 2. The question asked is going to determine your discernment. "All who sense this may be God's will, vote yes."
- 3. Seek unity and unanimity rather than passage and winning. If there is objection, then ask if that person is willing to trust the discernment of others on the question. If not, postpone for prayer.
- 4. Rarely make rushed decisions. When in doubt, slow down.
- 5. Encourage people to listen to how God is speaking through others.
- 6. Remember that every discernment is provisional. We can always come back to re-discern.
- 7. Practice trust limitation and delegation (with the use of committees and task forces).

Pastor Lee is a graduate of Seoul Theological University in Korea, (B.A. & M.Div.) as well as Briercrest Seminary (M.A. in Organizational Management. He was ordained in 2000 in the Korean Holiness Evangelical Church (KHEC). From 2002 on, the KHEC has been in partnership with Knox College. The Moncton Korean Church was established in 2006, and Pastor Lee has been its Pastor since 2010. It is a congregation of 150 members. Many Koreans, about one-third of the congregation each year migrate to larger centres for meaningful employment opportunities. The congregation is seeking prayer for a new worship space and the next generation.

# ORDER OF THE DAY (3:50) ECUMENICAL GUEST: Dr. Olugbenga Adenuga (Redeemed Church Of God In Christ)

Pastor Olugbenga Adenuga was ordained a Pastor of the Redeemed Christian Church of God as a confirmation of the call of God to preach the gospel and raise people with vision and purpose. He was the founding Pastor of RCCG Overcomer's parish, Hlatikulu Swaziland. He relocated to Moncton, New Brunswick in 2003 and during his 5 years stay at Glad Tidings Pentecostal Church, served variously supporting the leadership and ultimately as a member of the Board of Deacons. He was also part of the Medical missionary team to Senegal in 2007.

As a dedicated teacher, Pastor and speaker, his primary focus is to equip the body of Christ with power to pursue their purpose with the kind of passion and perseverance that he exemplifies. He lives with the love of his life, A/P Olabisi and their children in Moncton and continues to practice as a Certified Family Physician in the community. Pastor Adenuga is also the District Superintendent for the church zone spanning Montreal to Nfld. and covering 12 churches and the convener of the yearly RCCG Men of Valor conference.

This past year two milestones were celebrated: the 170th anniversary of the college and the 100th anniversary of the building. There are now 150 students in the various academic programs. A Master of Pastoral Studies will be introduced in the fall of 2016. Into the future Knox has planned building renewal, faculty expansion, facility upgrading for online education. To finance these plans Knox has initiated a \$15 million capital campaign which has already received \$5 million through donations and pledges. She asked for the support of the whole church including every congregation.

# ORDER OF THE DAY: ACADIA DIVINITY COLLEGE D. Min Program The Rev. Dr. Stephen McMullin

The Moderator welcomed Dr. McMullin and invited him to address the court.

Dr. McMullin introduced Acadia Divinity College as the Faculty of Theology at Acadia University and an accredited member of the Association of Theological Schools. He highlighted the Doctor of Ministry program. "Learning once one has been in ministry is different than learning in preparation for ministry." He noted the global and ecumenical diversity in both faculty and students in the program. The student is free to choose an advisor from within his/her own denomination. Acadia has striven to make the program affordable and accessible. He offered further information at their website (<a href="http://www.acadiadiv.ca">http://www.acadiadiv.ca</a>).

The committee is thankful for the many ways our Synod Personnel share their gifts in ministry.

## **Camping Ministry Strategy:**

A special task force, established by Synod Council during its May meeting, was asked to address the request for a camping ministry strategy for the Synod including a historical overview of camping ministry within the Synod, and a rationale for funding and accountabilities. The following report focuses on three camps within the bounds of the Synod: Camp Geddie, Camp MacLeod, and Camp Kier. As part of our initial report we offer a brief history presenting the original purpose and reasons for establishing a camp. Following this, summary notes are given regarding funding and accountably. Finally, a summary of the Synod's current camping strategy is offered.

### **Historical Overview:**

# **Camp Geddie:**

In 1943, a special committee for Sabbath Schools and Young Peoples Society was appointed by the Synod to discuss the formation of a Synod Camp believing that camping was an effective means of Christian Education and spiritual growth for youth. The first Synod Camp was held at Camp Roderick at Sunnybrae, Nova Scotia in 1944. In that same year a former lobster factory/dance hall and 5 acres were purchased in Ponds, Nova Scotia (the heart of the current site of Camp Geddie). Children and youth attended from all over the Synod.

The ministry context of these decisions was a growing vision to augment the Sabbath School and Congregational youth programmes with camping experiences. That vision also gave birth to congregational camps throughout the Atlantic Provinces in places like Campbellton, Sunny Corner, and St. John, New Brunswick, St. John's, Newfoundland and Sunnybrae, Nova Scotia, to name a few. Presbytery camps also developed in Prince Edward Island and Cape Breton.

The facilities have seen significant development over the years with the building of individual and double cabins and the Margaret McDougall A Frame Lodge through the completion of the Irwin Lodge in 1989, a new crafts hall, a new washing facility, a new infirmary, new cabins, and a new marina to host the canoe programme. In 1990 an additional 10.5 acres were purchased.

With the completion of the winterized Irwin Lodge in 1989 a new phase of ministry was opened in winter retreats for organizations and congregations of the Synod. During this period and into the next two decades the focus of staffing at the camp changed. Young people, aspiring to further education were seeking paid employment and were not available for volunteer positions. Gradually government grants became available to assist with this expense but there was also a need to increase the financial commitment of the Synod to address this need.

In the late 1990's the need for an executive director was identified. This grew into an inclusion of this responsibility within the ministries of Synod Staff and eventually the Synod Youth and Camping Consultant.

## **Camp MacLeod:**

It was during the post-war period (around 1945) that at least one minister in the Presbytery of Cape Breton advocated for a camp for Presbyterian young people within the Presbytery. By the early 1950s a camp was purchased from a Sydney service organization who had run the facility as a camp for under-privileged children. The first camp was held in either 1952 or 1953 under the Presbyterian banner. The camp has operated under the Presbytery of Cape Breton from its

inception to the present.

A significant driving force for the creation of the camp was to provide a Christian camping experience for Presbyterian youth of the Presbytery that could be easily accessed. Realistically today, the campership, and staff, is made up participants from a variety of denominational backgrounds, and even no church background. Part of its current philosophy is to be an outreach in Christian community and faith to those who attend.

In these times few youth have available parents or guardians who are willing to drive to Camp Geddie from Cape Breton so this seems to be "a barrier" for participation at Camp Geddie.

## Camp Keir:

Presbyterians have led the way in regards to camping ministry on the Island. While the Island currently has 5 Christian camps, Camp Keir is the longest running.

It had its origins in 1947 when Rev. Jim McGowen, who was serving in Kensington at the time, bought some property in French River for the purposes of establishing a Presbyterian camp for our young people here on the Island. At the time, it was felt that sending our youth to Camp Geddie was not a feasible option for Island parents. The reasons for this were two-fold: first the travel and expense of transporting children back forth was unrealistic, and at the time Geddie was always running near full capacity.

As the years progressed, things began to change. A change in the ocean currents resulted in a much less appealing swimming situations and the numbers of those enrolling in our camps continued to decline.

These challenging circumstances caused presbytery to re-examine its camping ministry. It was proposed by some that a change of location might be the catalyst to breathe new life into our camping ministry. Land was purchased in Canoe Cove. During this period the Canoe Cove Church and the Charge of Central Parish really took hold of things and were integral in the operation and on going maintenance of the new building(s).

# **Funding and Accountability:**

#### Camp Geddie:

The camp is owned and operated by the Synod of the Atlantic Provinces, with oversight provided by the Synod's Camp Geddie Committee, which reports to the Synod council and the Synod. The camp is accountable to the Synod, which receives annual reports of it ministry and finances. While funding for the camp comes from various sources the Synod does contribute a significant portion to support its camp.

## **Camp MacLeod:**

Financially, each congregation is assessed by the Presbytery on a per household formula on an annual basis. There are also opportunities to make special contributions. The last several years the camp committee has initiated a pantry drive for designated food items. Last year there was a "wish list" circulated among the congregations for needed up grades to equipment at the camp. Some congregations provide camperships for their youth to attend; the camp does have a campership fund that was initially set up through a bequest at Bethel, Sydney. We acknowledge the considerable financial support the Presbytery of Cape Breton provides for Camp MacLeod. It is the Presbytery that oversees the operation of this camp.

# Camp Keir:

The Camp does its own fundraising. Congregations are encouraged to support it as well by mean

of fundraising and donations. We acknowledge the considerable financial support the Presbytery of Prince Edward Island provides for Camp Keir.

It is the Presbytery that oversees the operation of this camp.

## **Synod's Current Camping Strategy:**

All the Camps within the Synod grew out of a calling to augment and support Christian Education among our young people. It is clear that while this focus on Christian Education continues, the camps note that this calling includes more than "our" Presbyterian young people as the camps offer Christian witness to young people from different denominations and from no church affiliation.

As stated in the historical overview the synod founded, and continues to own and operate, Camp Geddie to be a means of Christian education, spiritual growth and leadership training for our young people coming from various presbyteries, denominations and non-church back grounds within Atlantic Canada. The Synod also offers a camping experience to young people in presbyteries that do not have a presbytery camp. The Synod also offers an opportunity for young people to camp with people from other presbyteries, an experience which is continued in our synod youth events.

The Synod employs a Camping and Youth Consultant who serves as Executive Director of Camp Geddie to oversee and participate in the operation, administration, and promotion of the Synod Camp. The Executive Director provides direction and pastoral care to the campers and staff to promote the building up of young people in their relationship with Christ and each other. Given that it is not feasible in many cases for young people from PEI and Cape Breton to attend Camp Geddie these presbyteries have "filled a gap" by offering a more accessible means for Christian education through camping within their bounds. While Camp Keir and Camp MacLeod are not owned by nor held directly accountable to the Synod the Synod offers support to these camps recognizing their vital role in extending the camping opportunity in locations more accessible and feasible.

To offer support to Camp Keir and Camp MacLeod the Synod includes within its budget a grant for each camp. Furthermore, the Synod has assigned to its Camping and Youth Consultant the tasks of promoting camping ministry to the Synod, which would be inclusive of Synod and Presbytery Camps. The Synod also calls upon its Camping and Youth consultant to be a resource to Camps Keir and MacLeod and provide training.

#### **Independent Auditor's Report**

To the Council of The Synod of the Atlantic Provinces

I have audited the accompanying financial statements of the Synod of the Atlantic Provinces, which comprise the statements of financial position as at December 31, 2014 the statements of operations and changes in net assets and cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

## **Notes to the Financial Statements**

December 31, 2014

#### 1. DESCRIPTION OF OPERATIONS

The Synod of the Atlantic Provinces (the "Synod") is a court of the Presbyterian Church of Canada which oversees and supports presbyteries, congregations and joint ministries in the Atlantic Provinces. Transactions with these related parties are recorded at the exchange amount. The Synod is a registered charity and is exempt from income taxes.

The Synod provides administrative services for a prison outreach program operated by the Presbytery of Halifax – Lunenburg. Expenses are netted against program funding from the Province of Nova Scotia and have no effect on the statement of operations and changes in net assets.

#### 2. ACCOUNTING POLICIES

The financial statements have been prepared in accordance with Canadian accounting standards for not-for-profit organizations in Part III of the CICA Handbook and include the following significant accounting policies:

Revenue recognition

The Synod uses the deferral method of accounting for revenue. Under the deferral method of accounting, restricted contributions related to expenses of future periods are deferred and recognized as revenue in the period in which the related expenses are incurred. Unrestricted contributions are reported as revenue when they are received or receivable, if the amount to be received can be reasonably estimated and collection is reasonably assured.

Cash and cash equivalents

Cash and cash equivalents represent amounts on deposit and short-term investments with a financial institution with maturities of three months or less.

Trust funds

Trust fund investments are primarily comprised of guaranteed investment certificates. Interest rates range from 0.20% to 1.70%.

Capital assets

Capital assets are stated at cost and are amortized using the diminishing-balance method at the following annual rate:

Financial instruments

The Synod initially measures its financial assets and financial liabilities at fair value. It subsequently measures all of its financial assets and financial liabilities at amortized cost.

Transaction costs related to financial instruments measured at fair value subsequent to initial recognition are expensed as incurred. Transaction costs related to other financial instruments are added to the carrying value of the asset or netted against the carrying value of the liability and are then recognized over the expected life of the instrument using the effective interest method.

#### 2. ACCOUNTING POLICIES (continued)

Use of estimates

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the reporting date of the financial statements and the reported amounts of revenues and expenses at the reporting period. Significant estimates used in these financial statements include the allowance for doubtful accounts receivable, and certain accrued liabilities. Actual results could differ materially from those estimates. These estimates are reviewed periodically and adjustments are made, as appropriate, in the statement of operations in the year they become known.

#### 5. PENSION PLAN

The Synod is a member of The Presbyterian Church in Canada Pension Plan which was established to provide retirement income for eligible individuals. The plan is a contributory multi-employer defined benefit pension plan. The Synod has accounted for this pension plan as a defined contribution pension plan because sufficient information is not available to use defined benefit plan accounting. The Synod recognizes the contributions required to be made under the plan as an expense. Total combined employer and employee contributions for the year were \$5,108 (2013 - \$11,442).

#### 6. FINANCIAL INSTRUMENTS

Fair value

The fair value of cash and cash equivalents, accounts receivable, and accounts payable and accrued liabilities approximates their carrying value due to their relative short-term nature. The fair value of trust fund investments approximates their carrying value due to the nature of the investments.

Credit risk

The Synod performs an evaluation of accounts receivable and records an allowance for doubtful accounts as required. At December 31, 2014 the allowance for doubtful accounts, which offsets accounts receivable, was \$16,663 (2013 - \$8,331).

Interest rate risk

The cash equivalents and trust fund investments bear interest at fixed rates. Consequently, the cash flow exposure is not considered to be significant.

Liquidity risk

The Synod's objective is to have sufficient liquidity to meet its liabilities when due. The Synod monitors its cash balances and cash flows generated from operations to meet its requirements. Given the Synod's currently available liquid resources, as compared to its contractual obligations, management assesses the Synod's liquidity risk to be low.

#### 7. COMMITMENT

The Synod has committed to fund \$5,000 per year until 2018 to support the Presbytery of Prince Edward Island's debt reduction.


## The Summer Ministry of the Camp

The Commissioning of Staff was held at Camp Geddie on May 31st with the Moderator of Synod, the Rev. Jeffrey Murray, leading a service of Word and Sacrament. A barbecue was held after the service. This service as usual was open for anyone to attend.

During the month of June, Geddie hosted 18 school groups from Pictou Country, Truro and Antigonish with an average of 58 students per visit. The Geddie staff provided the students with a day of camp programming and an opportunity to experience our unique community. The Camp gains many summer campers through this program. Again there were more requests than could be accommodated.

There were 481 campers at Camp Geddie, a slight decrease from 2014. The Camp welcomed campers from across the Synod, several from Ontario, some from other parts of Canada, and one from Switzerland.

9 camp sessions were held during July and August ranging in ages from 7-18. Below is a pie chart offering a visual representation of the breakdown of the ages of the campers.



Camp Geddie hosted campers from several denominations: Presbyterian, United, Roman Catholic, Anglican, Baptist, Christian Reformed, Evangelical, Methodist, Lutheran, Born Again Christian, and Mormon. There were many campers with no denominational ties.

There were 22 campers on campership this summer. \$5342.00 was used from the Campership Fund to support these children coming to camp. This program is an invaluable opportunity and experience that Geddie offers. For many of these campers, this was their first experiences of Christian community and love. This is an affirmation of the experience that Camp Geddie provides, the love that is shown, and the work of the Holy Spirit flowing through Camp staff. Many of the parents took the time to express gratitude for the Campership program.

### **Program Committee**



The Executive Director in her report to the Camp Committee had this to say about the summer personnel and program:

"Camp Geddie had 29 amazing young people on staff this summer. We had many new staff this summer and all five of our program staff were new to leading their program. This brought a great freshness to the programs. The staff members were a dedicated team who demonstrated great care for one another, for the campers, and for the community. They valued personal and communal growth and they were courageous in their leadership. These young people decided to show up to engage the world, to engage Christ and chose to try and be present to the needs of others and to the needs of Christ. They chose to be vulnerable, to be themselves and to accept the joy and pain of community living. We shared in moments of struggle, pain and challenge but also in moments of joy, moments of celebrations and connection. The growth of the staff over the summer was a blessing to watch. As the summer progressed we got better at sharing the camp story and teaching about Christian community. It was a joy to experience how the staff interacted with one another and the campers. I am so thankful and blessed to have been a part of such an enriching, dynamic and motivating experience.

We began our onsite camping ministry work on May 20th. I, and the four leadership team summer staff were onsite for three days together planning and preparing for our first staff training weekend. Following the training weekend all full-time staff moved to the camp and we had a week to prepare for school groups and begin planning for our summer camping program. Beginning June 1st we had a school group every day until June 25th."



There were 10 wonderful participants in the Leader-In-Training (LIT) program. All of the LIT participants showed great potential and maturity throughout the program. The Camp had a chaplain at each camp and appreciated their interest.

The Bible Study material used at Camp is created by 'InsideOut: Christian Resources for Outdoor Ministries' and is supplied by Canadian Ministries of The Life and Mission Agency of The Presbyterian Church in Canada. The theme of the study this summer was Power Up: Living in the Spirit. The study aimed to teach campers about the Holy Spirit and to realize that the Holy Spirit empowers them to live with grace and forgiveness, unity and courage, joy and peace.

Camp Geddie hosted a Variety Show and Dessert Fundraiser on June 19 at First Presbyterian Church, Stellarton. It was a night of fun, fellowship and support. The staff, along with members of the community, "Friends of Geddie," performed a variety of acts.

On July 11, Camp Geddie hosted an open house and Geddie Spageddie dinner. Camp Geddie continues to challenge churches to host Geddie Spageddie's in their local churches as fundraisers.

## **Property Committee**

A large number of mattresses were purchased; this was funded through a gift of \$10,000 from James MacLean of Calvin, Halifax and Ian MacLean of St Andrew's, Fredericton made in memory of their parents, the Rev. A. O. and Eva MacLean (Mrs. MacLean was the Halifax Hospital Visitor for many years). A bench has been made with some of the gift of the MacLean's and has been placed along one of the nature trail.

#### **Smith House Committee**

Last year the Camp Geddie Committee reported they were engaged in prayerful discernment concerning the future of Smith House. Seeking to be good stewards of the Synod's resources, the Committee decided in May that it was not feasible to do extensive repairs to Smith House; the House is to be demolished. This action followed much research, discussion and prayer.

#### **Finance Committee**

The Camp Geddie Committee is very grateful to receive the information that a generous gift will soon be received from the estate of the Rev. Donald MacKay and to receive \$33,672 from the Estate of Jean MacKay-Baudox.

The Finance Committee prepares the budget and provides assistance to the Treasurer. It also provides updates periodically to the Synod Council and the Synod Council Finance Committee

The 2015 proposed budget and the audited statements for 2014 are attached.

The Committee again received a very generous donation of \$15,000 from an individual- the same person who donated \$15,000 in 2013 and \$10,000 in 2014. The Committee is deeply grateful to this donor.

For many years Kent Williams has been our auditor and advisor; once again he audited our 2014 financials at no charge.

#### 70th Anniversary

During 2016, the Committee is making arrangements for a celebration of the 70th anniversary of the Camp. Information will be sent to Presbytery Clerks about the celebration.

## Recommendation 1 Adopted p. 19

That the budget which includes a grant of \$48,500 for the Operating Fund and \$6,500 for daily checks of the property to meet insurance requirements be approved.

The Committee gives hearty thanks to God for the ministry of Camp Geddie and for the prayers, interest, encouragement, and financial support of so many people.

## APPENDIX G MISSIONS COMMITTEE

#### September 2015

To simply be a committee this past year proved to be very difficult. Rev. Dawn Griffith was not able to carry forward the work and pace that came out of last year's report, and we know that this is a disappointment to her most of all, and our prayers are with her that she might be strengthened and supported in her recovery from this past year's troubles.

Rev. Sandy Sutherland was asked to be acting-convener after the spring meeting of Synod Council, and was asked to serve as full convener at the end of August, after which the committee was called to meet in September.

This transition in the life of this committee has resulted in some degree of difficulty in discerning the membership of this committee, and communication with it. If anyone has been left out of communication and correspondence we apologize. It is in the light of this year's difficulties however that a mission goal for this committee has formed; communication.

The committee itself will be exploring ways of being more effective in its internal communication, as well as ensuring the communication of it convener's position and materials easily. We hope to develop these means of communication within our body and then share this experience with the Synod and its committees. This will include modernizing of our record-keeping, establishing a schedule of quarterly meetings and correspondence within the Synod [an e-newsletter and/or web page update transmitted 4 times a year], continuing past year's effort to explore modes of efficient e-meeting models [conference call, modes of video-chat, and circulating email discussions].

This is made abundantly clear when looking at the standing mandate of this committee. The role of the Synod Mission Committee – over the past few years we have been working out a Synod Mission strategy we look over a list of roles that this committee looks after on behalf of the Synod. These roles are defined [in no particular order] as:

- 1. Justice Ministries
- 2. Relations with Life and Mission Agency and PWS & D
- 3. Canada Ministries
- 4. Rural Ministry
- 5. Coordination with the Atlantic Mission Society
- 6. Coordination with the Synod Staff Person, arranging for deputations within the Presbyteries of the Synod
- 7. Maintaining the Synod Audio-Visual Library
- 8. Developing a Synod Mission Strategy

In light of this, it was raised that perhaps without being re-mandated, it may be advisable – where appropriate – to share information with the Synod Program Committee, as well as be involved with the use of funds made available in place of a Synod Staff person. This is not create a redundancy in reporting, either through the Life and Mission Agency or with the Synod Program Committee, but to offer a place where events and programs offered through this funding can be communicated to the rest of the Synod; replacing the Synod Staff Person's report. Again, it is our hope that this will strengthen communication within the Synod.

## Recommendation 1: Adopted p. 17

That Synod grant the Synod Mission Committee a budget of \$3,500.00 for 2016.

Rev. Lara Scholey has been busy gathering and consolidating information; providing useful information to be shared through the Synod concerning the denomination's response to the Refugee Crisis out of Syria. The information packet outlined on the PWS&D web page (http://presbyterian.ca/pwsd/conflict-syria/) has important information regarding the work that our denomination has been focused on. We feel that we should

provide a venue for the response congregations are giving to this initiative, to pool and package information that is of particular interest to this Synod and ability of congregations in our region to respond, to extend the range of communication. We are thankful to Rev. Scholey in her continued work in making sure we have the best available information for mission action from PWS&D. This information is appended to this report.

We also discussed whether their might be some use in receiving a speaker to either speak to the Synod or to visit the presbyteries of this synod engaging our region in some response to this crisis. It was noted that there are people within the denomination quite capable of speaking on these issues, specifically Huda Candalaft of St. Andrew's Ottawa, who addressed Synod a few years ago. We do feel that the Synod should respond to this crisis in a timely manner.

#### Recommendation 2: Adopted p. 17

That the remaining funds in the Mission Committee's operating budget for 2015 be sent to "Syrian Refugee Relief" through PWS&D.

**Ongoing Outreach by the Synod:** We do want to have a discussion about whether the Synod allows for the operating budget to be reallocated for ongoing and emergency mission support within the Synod and what might be a guideline for such use; to allow presbyteries and congregation feel empowered to engage in mission initiatives throughout the Synod.

As well, it is felt that this is not the time to radically change the traditional funding that has been offered to either the Atlantic Mission to the Deaf or Coverdale Saint John NB, Halifax NS. We will be asking for some additional information with the presbyteries where the work of these agencies continue.

We are looking for correspondence from these agencies to ensure that our support continues to be effective, appreciated and well used. We wish to ask Coverdale to present again on its continued mission at Synod in 2016. We wish to ask Atlantic Mission to the Deaf to speak in 2017.

#### Recommendation 3: Adopted p. 18

That the donation to the Atlantic Ministry of the Deaf be maintained at \$2,000.00 for 2016.

#### Recommendation 4: Adopted p. 18

That the 2016 donation to Coverdale remain at \$6,000.00, to be equally divided between Coverdale, Halifax, NS and Coverdale, Saint John, NB.

The Mission Committee prepared its annual Synod bulletin insert, presented this year in two formats. One way showed the prayer on the left and the description of Synod on the right, so that it could be used as a bulletin cover if congregations so chose. The other way was the usual one for use as an insert. The committee hopes the congregations found it helpful in understanding the place of Synod within the Presbyterian Church in Canada

We continue to be mindful of the work of missional work that in ongoing within our Synod and we are seeking for examples and stories of mission. We have received thanks for the support that was offered to mission within our Synod last year and we are actively looking for mission work to support in the future.

Please keep this committee in thoughts and prayers as we engage in what will be a year of discernment and be open to the learning that our shared experiences of mission will give us.

# APPENDIX N SYNOD CAMPING STRATEGY Historical Overview:

#### Camp Geddie:

In 1943, a special committee for Sabbath Schools and Young Peoples Society was appointed by the Synod to discuss the formation of a Synod Camp believing that camping was an effective means of Christian Education and spiritual growth for youth. The first Synod Camp was held at Camp Roderick at Sunnybrae, Nova Scotia in 1944. In that same year a former lobster factory/dance hall and 5 acres were purchased in Ponds, Nova Scotia (the heart of the current site of Camp Geddie). Children and youth attended from all over the Synod.

The ministry context of these decisions was a growing vision to augment the Sabbath School and Congregational youth programmes with camping experiences. That vision also gave birth to congregational camps throughout the Atlantic Provinces in places like Campbellton, Sunny Corner, and St. John, New Brunswick, St. John's, Newfoundland and Sunnybrae, Nova Scotia, to name a few. Presbytery camps also developed in Prince Edward Island and Cape Breton.

The facilities have seen significant development over the years with the building of individual and double cabins and the Margaret McDougall A Frame Lodge through the completion of the Irwin Lodge in 1989, a new crafts hall, a new washing facility, a new infirmary, new cabins, and a new marina to host the canoe programme. In 1990 an additional 10.5 acres were purchased.

With the completion of the winterized Irwin Lodge in 1989 a new phase of ministry was opened in winter retreats for organizations and congregations of the Synod. During this period and into the next two decades the focus of staffing at the camp changed. Young people, aspiring to further education were seeking paid employment and were not available for volunteer positions. Gradually government grants became available to assist with this expense but there was also a need to increase the financial commitment of the Synod to address this need.

In the late 1990's the need for an executive director was identified. This grew into an inclusion of this responsibility within the ministries of Synod Staff and eventually the Synod Youth and Camping Consultant.

#### Camp MacLeod:

It was during the post-war period (around 1945) that at least one minister in the Presbytery of Cape Breton advocated for a camp for Presbyterian young people within the Presbytery. By the early 1950s a camp was purchased from a Sydney service organization who had run the facility as a camp for under-privileged children. The first camp was held in either 1952 or 1953 under the Presbyterian banner. The camp has operated under the Presbytery of Cape Breton from its inception to the present.

A significant driving force for the creation of the camp was to provide a Christian camping experience for Presbyterian youth of the Presbytery that could be easily accessed. Realistically today, the campership, and staff, is made up participants from a variety of denominational backgrounds, and even no church background. Part of its current philosophy is to be an outreach in Christian community and faith to those who attend. We acknowledge the considerable financial support the Presbytery of Cape Breton provides for Camp MacLeod.

In these times few youth have available parents or guardians who are willing to drive to Camp Geddie from Cape Breton so this seems to be "a barrier" for participation at Camp Geddie.

#### Camp Keir:

Presbyterians have led the way in regards to camping ministry on the Island. While the Island currently has 5 Christian camps, Camp Keir is the longest running.

It had its origins in 1947 when Rev. Jim McGowen, who was serving in Kensington at the time, bought some property in French River for the purposes of establishing a Presbyterian camp for our young people here on the Island. At the time, it was felt that sending our youth to Camp Geddie was not a feasible option for Island parents. The reasons for this were two-fold: first the travel and expense of transporting children back forth was unrealistic, and at the time Geddie was always running near full capacity.

As the years progressed, things began to change. A change in the ocean currents resulted in a much less appealing swimming situations and the numbers of those enrolling in our camps continued to decline.

These challenging circumstances caused presbytery to re-examine its camping ministry. It was proposed by some that a change of location might be the catalyst to breathe new life into our camping ministry. Land was purchased in Canoe Cove. During this period the Canoe Cove Church and the Charge of Central Parish really took hold of things and were integral in the operation and on going maintenance of the new building(s).

#### **Funding and Accountability:**

#### Camp Geddie:

The camp is owned and operated by the Synod of the Atlantic Provinces, with oversight provided by the Synod's Camp Geddie Committee, which reports to the Synod council and the Synod. The camp is accountable to the Synod, which receives annual reports of it ministry and finances. While funding for the camp comes from various sources the Synod does contribute a significant portion to support its camp.

#### Camp MacLeod:

Financially, each congregation is assessed by the Presbytery on a per household formula on an annual basis. There are also opportunities to make special contributions. The last several years the camp committee has initiated a pantry drive for designated food items. Last year there was a "wish list" circulated among the congregations for needed up grades to equipment at the camp. Some congregations provide camperships for their youth to attend; the camp does have a campership fund that was initially set up through a bequest at Bethel, Sydney. It is the Presbytery that oversees the operation of this camp.

#### Camp Keir:

The Camp does its own fundraising. Congregations are encouraged to support it as well by mean of fundraising and donations. We acknowledge the considerable financial support the Presbytery of Prince Edward Island provides for Camp Keir.

It is the Presbytery that oversees the operation of this camp.

## **Synod's Current Camping Strategy:**

All the Camps within the Synod grew out of a calling to augment and support Christian Education among our young people. It is clear that while this focus on Christian Education continues, the camps note that this calling includes more than "our" Presbyterian young people as the camps offer Christian witness to young people from different denominations and from no church affiliation.

As stated in the historical overview the synod founded, and continues to own and operate, Camp Geddie to be a means of Christian education, spiritual growth and leadership training for our young people coming from various presbyteries, denominations and non-church back grounds within Atlantic Canada. The Synod also offers a camping experience to young people

in presbyteries that do not have a presbytery camp. The Synod also offers an opportunity for young people to camp with people from other presbyteries, an experience which is continued in our synod youth events.

The Synod employs a Camping and Youth Consultant who serves as Executive Director of Camp Geddie to oversee and participate in the operation, administration, and promotion of the Synod Camp. The Executive Director provides direction and pastoral care to the campers and staff to promote the building up of young people in their relationship with Christ and each other. Given that it is not feasible in many cases for young people from PEI and Cape Breton to attend Camp Geddie these presbyteries have "filled a gap" by offering a more accessible means for Christian education through camping within their bounds. While Camp Keir and Camp MacLeod are not owned by nor held directly accountable to the Synod offers support to these camps recognizing their vital role in extending the camping opportunity in locations more accessible and feasible.

To offer support to Camp Keir and Camp MacLeod the Synod includes within its budget a grant for each camp. Furthermore, the Synod has assigned to its Camping and Youth Consultant the tasks of promoting camping ministry to the Synod, which would be inclusive of Synod and Presbytery Camps. The Synod also calls upon its Camping and Youth consultant to be a resource to Camps Keir and MacLeod and provide training.
