The Kirk-Session held five regular meetings, four special meetings, and met once with the Board of Managers in a joint meeting. Additionally the Session met jointly with St. Paul's Glammis six times. The Sacrament of Holy Communion was celebrated five times at Knox Church Tiverton. In 2016 we delivered two issues of Knox News to members and adherents. The last Sunday of the month remains Grocery Sunday and it is with joy that we have provided much needed food items and monetary donations to the local Food Bank on a monthly basis.

In January 2016 our pulpit became vacant and Rev. Owen Kim was our Interim Moderator. A Search Committee comprised of Co Chairs Stan Eby and Heather Catto, members, Eileen Simpson, Nancy Alexander, Blair Kempers, Anne Gratto and Ernie Young worked diligently on the preparation of a Call document and were successful in inviting Mr. David Chang to preach for the Call at Knox Tiverton on Sunday, May 15th. The Knox Auxillary is a committee of four (Rosemary Grover, Cora Lee Dobson, Gerda Roppel, and George Potter). This committee organized the 2 church suppers, provided 5 funeral lunches, one celebration of life lunch and prepared a dinner for the Tiverton Fall Fair Ambassador contestants.

The committee spearheads the 2 church suppers, but all the congregation working together make them a success. The menu for the summer supper included cold roast beef, ham, various salads and delicious pies. At this supper 370 adults and 18 children ate and a total profit of \$5,558.05 was realized. The menu for the fall supper included turkey and all the trimmings, (but NO turnip) and of course yummy pies. There were 374 adults and 2 children served realizing a profit of \$5625.00. The profits from these two suppers go directly into the General Church operating account.

The Auxillary is very fortunate to have help from Norm Dobson and Chuck Exel as well as other members of the congregation in preparing the funeral lunches. The Expert Butter Spreader "Floyd" is really missed.

The Knox Auxillary took on another task of fund raising for new chairs for the Church's activity room. The goal is to purchase 100 chairs. If a funeral lunch or any other large gathering is held in the church, at present there are only about 64 chairs. In order to raise money the auxillary spearheaded the summer barbeques. There were 4 barbeques held, realizing a profit of \$828.00. The auxillary also held a yard sale with the \$1726.00 profit going to the chair fund. Again these two events could not have been held without the support of the congregation. The first Soup Luncheon in September proceeds of \$186 went to the chair fund. The Knox Auxillary donated \$2000 to the chair fund. As of now the chair fund is sitting at \$5741.00

The Auxillary contributed \$700 towards paint for the interior of the manse .

^{*}Upper bath renovations consisted of new counter top to include double sinks/taps and new vanity. New lighting in living room plus new vent covers.

^{*}Final modernization was in kitchen where a new counter top (matching island top) was installed with new tile back splash.

KNOX CHURCH FUNDS

This page refers to different funds in our church and offers a brief explanation of each.

MEMORIAL RENOVATION FUND

PURPOSE: The Memorial Renovation Fund was established at the Annual Congregational meeting, January 25, 1979 and amended at a special congregation meeting June 29,1988. The fund was established to provide a fund for those wishing to make memorial gifts or any unspecified bequests to the church; and to provide a fund for major renovations and restorations of the church or manse buildings and property and the replacement of Sanctuary furnishings.

PROCEDURE: The Treasurer receives funds from donors and sends thank you cards to the donors. The Treasurer notifies the Board of Managers and records the fact in the Memorial Book that a memorial gift has been received in memory of a particular person(s) or that a bequest has been received from the person named. If the memorial gift or bequest is, or exceeds, \$500.00, this information is forwarded to the Stewardship Committee who co-ordinates the wording and installation of a plate on the Memorial Plaque and notification in the Sunday bulletin.

FUND MANAGEMENT: The fund is administered by the Treasurer upon instructions from the Board of Managers. Release of funds is approved by a duly called meeting of the congregation where the Board of Managers present their detailed case.

GRANT HELM ESTATE TRUST FUND

Early in 1980, the Board of Managers, on behalf of the congregation, received a bequest of \$5000 from the estate of the late Grant Helm. It was specified that the interest from the invested funds be used for the purchase, renovation or repair of equipment for the Sunday School; and the redecoration, renovation and improvement of the Sunday School room.

HUGHES-MCKELLAR MEMORIAL FUND

In 1997, Miss Margaret Hughes of London, Ontario donated \$50,000.00 to our church to establish the Hughes-McKellar Memorial Fund. The principal amount of \$50,000 is to be invested in perpetuity. The yearly interest from the fund is to be used as follows:

- 1. One half of the interest to be given to the W.M.S. for mission projects as they see fit.
- 2. On half of the interest to be given to the Board of Managers choir needs to be met first, the remainder used as the Board of Managers see fit.

THE OUTREACH FUND

At the Annual Congregational Meeting, January 31, 2000 the Knox Church Tiverton Outreach Fund was established. This fund is contributed to by the congregation, separate from Presbyterians Sharing Allocation. Funds are used for local benevolent needs, mission outreach and other Congregational Life Activity expenses at the discretion of the Session.
