FROM THE DESK OF REV. RICHARD WARNE

I have fully enjoyed being your minister for just over a year now. When I entered Knox College I felt called to a Chaplaincy type ministry in a hospital or prison. At Knox College I was assigned a professor as a mentor, confidant or counselor to walk with me through the journey to ordained ministry. It was my professor that steered me into parish ministry. I was pretty sure I wouldn't fit in a large city church and would be more comfortable in a smaller or rural congregation. During my studies I tried to determine what model of ministry would best suit me as a minister. After reading Kennon Callahan, talking with my professors, and reading other books by church consultants, I felt the best model for me was to be a "community pastor". You might wonder what that looks like. It takes time to develop that kind of relationship in a small community.

Some of the things you do as a "community pastor" is to make yourself available to the people in the community and build personal relationships with them. I do that by walking my dog around town and visiting the people I meet. I joined the Tiverton ministerial and have participated in the Tiverton Fall Fair community worship service, Remembrance Day services and lead worship at the Manor about every five weeks. After the worship services at the Manor I try to visit and get to know our members and other residents. I also volunteer at the Huron Shores Hospice at the Manor as a spiritual guide and I'm available to visit at anyone's request. I try to take in community events like the Fair, Lion's garage sales, and special dinners or breakfasts. In 2023 I will work with Rev Rob Hiscox to organize a special worship service to thank our first responders. I am trying to get to know as many people as I can inside and outside the church.

Here are some of the highlights of last years ministry together. I led or participated in about 60 live worship services at the church, community and retirement homes. I posted 46 worship services on our YouTube channel and our Facebook page. I posted devotions and Revrick reflections on our Facebook page. Part of building relationships in the area is by participating in Presbytery as a presbyter, Chair of the Transition Committee and as a member of the administrative committee. I attended 24 work related Presbytery meetings as well as session, board of managers and congregational meetings. I had many visits with our members and non-members in the hospital, at home, by email and on the phone.

I did my first baptism of Beau Barry Hall and have started conversations for a wedding in June of 2023. On a sadder note I officiated at 14 funeral and graveside services. We buried five members of our congregation: Angus McKay, Don Campbell, Eileen Alexander, Doris Young and Irene MacKinnon. I officiated at six funerals for family members or by request: Gary Hammond, Brian Hammond, Don Inkster, John Thompson, Margaret Wonfor and Eunice Brown. We lift up all those who lost loved ones this year and pray the Lord will provide the families with peace and comfort.

From 1st Corinthians 12: 4-7, 11, "4 Now there are varieties of gifts, but the same Spirit; 5 and there are varieties of services, but the same Lord; 6 and there are varieties of activities, but it is the same God who activates all of them in everyone. 7 To each is given the manifestation of the Spirit for the common good. 11 All these are activated by one and the same Spirit, who allots to each one individually just as the Spirit chooses."

I believe if we are doing what God has called us to do or be, God will provide the necessary gifts to fulfill our mission. The world around us is changing but the mission of the church has not changed in two thousand years. We still need to reach out to the community and share the good news of the gospel in the name of Christ through volunteering, participating, financial contributions, building relationships, prayer and worship.

Jeff Simpson moved adjournment and Rev. Rick closed in prayer and gave the benediction. Next meeting February, 2023.

CONGREGATIONAL MEETING – MARCH 6, 2022

A congregational meeting of Knox Presbyterian Church, Tiverton was held on Sunday March 6, 2022 following worship service. This meeting was called to discuss the purchase of three 75 inch TV monitors that will be placed in the sanctuary to replace the present screen and projector. Reverend Rick Warne opened the meeting with a prayer. Rosemary Grover volunteered to act as Secretary for the meeting. A motion to allow all parishioners present be allowed to vote was made by Rosemary Grover, seconded by Gerda Roppel. Motion carried.

Don MacArthur explained where the monitors would be placed and mentioned what monies had been received to buy the monitors (Presbytery grant \$1890.97 ((\$2000 - \$109.03)), Hunter estate \$2000, St Paul's NVF \$1049.85) for a total of \$4940.82. Don stated that the monitors from HDTV, Walkerton would cost approximately \$7300.

Motion by Don MacArthur, seconded by Rosemary Grover to approve the spending of up to \$3000 from The Memorial Renovation Fund to upgrade the church's technology by installing the monitors in the sanctuary. Motion carried.

Motion by Carol Love, seconded by Lorrie Alexander to adjourn the meeting. Reverend Rick Warne closed the meeting with a prayer.

CONGREGATIONAL MEETING - DECEMBER 4, 2022

A congregational meeting of Knox Presbyterian Church, Tiverton was held on Sunday December 4, 2022 following worship service. This meeting was called to discuss the church's heating system. Reverend Rick Warne opened the meeting with a prayer.

Lorrie Alexander mentioned that the church will need to pay Epcor \$2500 if the gas line is not hooked up. Lorrie Alexander explained that the geothermal system does not function sufficiently when the temperature drops below zero. Lorrie mentioned that four companies were contacted and only two replied, Climate Clinic and Cliff's Plumbing and Heating.

Motion by Rosemary Grover, seconded by Carol Love to allow any adherent members present to vote. Motion carried.

Motion by Don MacArthur, seconded by Alex Duthie to spend up to \$25,000 from the Memorial Renovation Fund to accept the estimate from Cliff's Plumbing and Heating which is approximately \$20,000 to upgrade the heating system by replacing the electrical coils in the existing geothermal system with hot water coils. The hot water boilers will need gas to operate.

Motion carried

Reverend Rick closed the meeting with a prayer.

Another busy year for the board with several upgrades and changes.

Following are a list of our activities:

- *3 75" television monitors were installed in the sanctuary
- * There were 4 summer bbq's held at the Church
- * Yard sale (that had everything you could possibly imagine including a kitchen sink)
- *Church front steps and a section of sidewalk were repaired and railings repainted
- *Main parking lot door weather stripping was replaced
- *A number of geothermal heating repairs and additions

Two of the areas above the well heads that were sinking (on the west side of the Church) were dug up. Thankfully we had Stan Eby's backhoe, Jeff Simpson and Don McArthurs' tractor and an assortment of shovels, rakes and some kitchen utensils. We are hopeful we have repaired the sinking by backfilling with sand, washed gravel and top soil. We are currently in the process of replacing the supplementary electrical heating coils on the geothermal furnace with a natural gas boiler system and coils that will give us reliable heating in the winter with a reduced electrical bill while still maintaining the air conditioning. Wifi thermostats will be installed so we have remote control of the temperature.

As usual many talented people have stepped forward to research and participate in these projects. Thank you. We have a very diverse and talented membership.

Special thanks to Barry Blackett who maintains the lawn and does the walkway clearing, Carol for making the planters and area around the digital sign look so welcoming as well as the garden girls for all their work on the many flowerbeds.

PURPOSE: The Memorial Renovation Fund was established at the Annual Congregational meeting, January 25, 1979 and amended at a special congregation meeting June 29,1988. The fund was established to provide a fund for those wishing to make memorial gifts or any unspecified bequests to the church; and to provide a fund for major renovations and restorations of the church or manse buildings and property and the replacement of Sanctuary furnishings.

PROCEDURE: The Treasurer receives funds from donors and sends thank you cards to the donors. The Treasurer notifies the Board of Managers and records the fact in the Memorial Book that a memorial gift has been received in memory of a particular person(s) or that a bequest has been received from the person named. If the memorial gift or bequest is, or exceeds, \$500.00, this information is forwarded to the Stewardship Committee who co-ordinates the wording and installation of a plate on the Memorial Plaque and notification in the Sunday bulletin.

FUND MANAGEMENT: The fund is administered by the Treasurer upon instructions from the Board of Managers. Release of funds is approved by a duly called meeting of the congregation where the Board of Managers present their detailed case.

In 1997, Miss Margaret Hughes of London, Ontario donated \$50,000.00 to our church to establish the Hughes-McKellar Memorial Fund. The principal amount of \$50,000 is to be invested in perpetuity. The yearly interest from the fund is to be used as follows:

- 1. One half of the interest to be given to the W.M.S. for mission projects as they see fit.
- 2. One half of the interest to be given to the Board of Managers choir needs to be met first, the remainder used as the Board of Managers see fit.

ST. PAUL'S NEW VENTURE TRUST FUND

In January 2020 St. Paul's Presbyterian Church in Glammis amalgamated with Knox Presbyterian Church in Tiverton. In preparation for amalgamation, St Paul's church property was sold and a "New Venture Fund" was established in the amount of \$74,000.
