#### FROM THE DESK OF REV. RICHARD WARNE

Last year I described what it looked like for me to be a "community pastor", but also described what I felt the congregation should be like. We are to build relationships inside and outside of the church building. We continued to build relationships in the community. As a congregation we participated in Winterfest, collected for the Canada Foodgrains Bank, hosted a meet your neighbour BBQ for the community, participated in the Tiverton Fall Fair, collected items for Evangel Hall and led a Service of Memories for those who have lost loved ones in the past year. We hosted a lunch after the community Remembrance Day service to name a few. The Knox Auxiliary served the community by providing funeral lunches.

As part of the Tiverton ministerial, Knox hosted an afternoon service for the community to thank our First Responders for their service and raised money for Camp Bucko. The attendance was wideranging and greatly appreciated. I lead worship at Tiverton Park Manor nine times with some of our non-residents joining. Leading these services allows me to get to know our members and other residents a little better. As the spiritual guide Huron Shores Hospice, I made eight visits to members and non-members by request.

Here are some other highlights of last year's ministry together. I led or participated in fifty-six live worship services at the church, community and the Manor. I posted forty worship services on our YouTube channel and Facebook pages. I posted devotions and Revrick reflections on our Facebook pages as well as sharing pictures from our services and notices of upcoming events. I am also posting information on the Tiverton Strong Facebook page. Part of building relationships in the area is by participating in Presbytery as a presbyter, Chair of the Transition Committee and as a member of the administrative committee. I attended twenty-five work related Presbytery meetings as well as Session, Board and Congregational Meetings. I had many visits with our members and non-members in the hospital, at home, by email and on the phone.

I officiated my first wedding for Braylin and Jacob Osborne and have started conversations for a wedding in June of 2024. On a sadder note, I officiated at ten funeral and graveside services. We buried seven persons from our congregation, Jean Dent, Phylis Paige, Audrey McKay, Jo Anne Potter (Committal), Marg McConnell, David Mackereth and Linda Scott. I also officiated at two funerals by request. We lift up all those who lost loved ones in the past year and pray the Lord will provide the families with peace and comfort.

Paraphrased from 1st Corinthians 12: 27-31, "27-31 You are Christ's body! You must never forget this. Only as you accept your part of that body does your "part" mean anything. You're familiar with some of the parts that God has formed in his church, which is his "body": apostles, prophets, teachers, miracle workers, healers, helpers, organizers, those who pray in tongues.

This passage is a reminder that God will provide the necessary gifts to fulfill our mission. The mission of the church has not changed in two thousand years. We still need everyone who is part of the congregation to contribute to the caring and sharing with our members and our community through volunteering, participating, financial contributions, building relationships, prayer, worship and fellowship. We would not be where we are today if it were not for the contributions of our church family.

This is a box of fresh fruit and vegetables that can be purchased for \$22 each month and delivered to the Church by a Lions Club member. The boxes are picked up from the Church. Anyone can purchase a good food box by signing up at Patz Pizza. Heather Hunter, Barry and Linda Blackett have taken the lead on this project.

We hosted 4 successful summer Monday BBQ's, a community yard sale and a very popular community BBQ on a Saturday evening. The Steinhoff family provided music, Barry led the organization of the event and Blair smoked the meat in a rather large, creative smoker.

Many thanks to everyone who helps in any way to care for the church property and make it a welcoming place to worship. Carol Love looks after the planters, the area around the digital signs and wages war against flies in the stairwell. Barry cares for the lawn and clears the walkway of snow in the winter. The garden girls (June, Cora Lee and Carol) keep the garden beds at the Church and manse well tended. Eileen Simpson looks after the digital sign and updates. #### MEMORIAL RENOVATION FUND

**PURPOSE:** The Memorial Renovation Fund was established at the Annual Congregational meeting, January 25, 1979 and amended at a special congregation meeting June 29,1988. If the memorial gift or bequest is, or exceeds, \$500.00, this information is forwarded to the Stewardship Committee who co-ordinates the wording and installation of a plate on the Memorial Plaque and notification in the Sunday bulletin. **FUND MANAGEMENT:** The fund is administered by the Treasurer upon instructions from the Board of Managers. Release of funds is approved by a duly called meeting of the congregation where the Board of Managers present their detailed case.
