#### FROM THE DESK OF REV. RICHARD WARNE - 2024

I completed my third year of ministry at Knox Tiverton in the fall. It is a strongly held belief that a minster's new ministry doesn't start until after his third year. Until that time they are learning the lay of the land, so to speak, and building relationships in the congregation and the community. I have been able to get to know many of the people in the congregation and my neighbours in the community as I walk Charlie in the morning and later in the day. I have built relationships at Presbytery with the ministers and the presbyters. I have built relationships with the local ministers in the Tiverton ministerial and worshiped together with them and the community at the Fall Fair service and Remembrance Day services. All of this is a reflection of my model of ministry as a "community Pastor". Over the past three years I have had an opportunity to share in the celebrations of the congregation and community, but I have also walked with them in their deepest sorrows and was on the receiving end of pastoral care in the death of our son, Bryan.

Here are some of the highlights of last year's ministry together. I led or participated in worship services at church, community and retirement homes. I posted worship services on our YouTube channel and our Facebook page. I posted devotions and reflections on our church and my Facebook pages. I have taken on a leadership role in Presbytery as the Chair of the Pastoral Care Committee and as a member of the Administrative Committee. I made many visits with our members and non-members in the hospital, at home, in hospice care and by email and phone.

On a sadder note, I officiated at several funeral and graveside services for members of the community, family and friends and we buried Helen McKenzie and Keith Brown from this congregation. We lift up all those who lost loved ones this year and pray the Lord will provide the families with peace and comfort that goes beyond our understanding, to get them through the grieving process.

The biggest challenge we still face as a congregation is the people to do the work God is calling us to do. When I read a devotional recently, it used a passage from Matthew identified as Ask, Search, Knock, which I think you are familiar with. The verses are found in 7: 7-8, "7 Ask, and you will receive. Search, and you will find. Knock, and the door will be opened for you. 8 Everyone who asks will receive. Everyone who searches will find. And the door will be opened for everyone who knocks." We may be discouraged by this passage when we seem to have unanswered prayers, but must remember, everything in God's time.

When Jesus was in the Garden of Gethsemane, in Matthew it is written, he prayed, "My Father, if it is possible, may this cup be taken from me. Yet not as I will, but as you will." Maybe the key to Ask, Search, Knock is the end of Jesus prayer, Yet not as I will, but as you will. If so, the question we ask should become, what does God want Knox Tiverton to do and how can we fulfill His will for this congregation.

My closing message this year is much the same as last year. God's mission in the world has not changed. I still believe, if we are doing what God is calling us to do, God will provide the necessary resources to fulfill His mission for this church in Tiverton Ontario. We still need to reach out to the community and share the good news of the gospel in the name of Christ through volunteering, participating, financial contributions, building relationships, prayer and worship for God's will to be done in our congregation.

#### THE MACLENNAN AUXILIARY W.M.S - 2024

#### **TEESWATER CROPSHARE REPORT - 2024**

As part of Teeswater Cropshare, Knox Presbyterian Church Tiverton celebrates our kickoff month on the first Sunday in May. The committee always sets a monetary goal which is always surpassed by you, the congregation and community.

Nineteen acres are rented and planted with soybeans, corn or winter wheat, with these crops being rotated. The crop is planted, maintained, harvested and sold by volunteer people and equipment. The crop is sold at market price.

There are nine churches involved and our donations go to pay for land rent, fertilizer, spraying, custom work, drying, handling, storage, carbon tax, check off, crop insurance, bank charges and HST.

This year, 2024, was year number thirty for our involvement. Reverend Rick Warne was our speaker and a lunch and social hour was had in our Activity Room following the service.

The audit for 2024 (soybeans) shows \$39,500.00 sent to the Canadian Foodgrains Bank and this was matched by the Canadian Government 4:1. This donation on behalf of the project is earmarked to partner with work of Presbyterian World Service and Development, a sum of \$197,500.00. This upcoming year, May 4, 2025 will be kickoff Sunday. On nineteen acres is growing winter wheat for 2025 with a 4:1 return.

#### MEMORIAL RENOVATION FUND

**PURPOSE:** The Memorial Renovation Fund was established at the Annual Congregational meeting, January 25, 1979 and amended at a special congregation meeting June 29,1988. The fund was established to provide a fund for those wishing to make memorial gifts or any unspecified bequests to the church; and to provide a fund for major renovations and restorations of the church or manse buildings and property and the replacement of Sanctuary furnishings. **PROCEDURE:** The Treasurer receives funds from donors and sends thank you cards to the donors. The Treasurer notifies the Board of Managers and records the fact in the Memorial Book that a memorial gift has been received in memory of a particular person(s) or that a bequest has been received from the person named. If the memorial gift or bequest is, or exceeds, \$500.00, this information is forwarded to the Stewardship Committee who co-ordinates the wording and installation of a plate on the Memorial Plaque and notification in the Sunday bulletin. **FUND MANAGEMENT:** The fund is administered by the Treasurer upon instructions from the Board of Managers. Release of funds is approved by a duly called meeting of the congregation where the Board of Managers present their

#### ST. PAUL'S NEW VENTURE TRUST FUND

In January 2020 St. Paul's Presbyterian Church in Glammis amalgamated with Knox Presbyterian Church in Tiverton.
