Mission Committee 2 people for a 2-year term

The Mission Committee has been established to help the congregation of Mill Woods Presbyterian Church (MWPC) to share in the work of the church by contributing towards meeting the needs of the greater community as concerned Christians interested in promoting the common good. To facilitate the ministry and witness of the congregation in the local, national, and international mission, its mandate is to encourage all members and adherents to participate actively in the support of mission projects.

The purpose of the Investment Committee is to decide how and where to invest the Strathcona Presbyterian Church Legacy Fund, the Building Fund, The Minister's Accommodation Fund, and the Transition Fund (the Funds) and to maintain oversight of investment performance.
