Sunday February 26, 2023

The annual congregational meeting of Caradoc Presbyterian Church was held on February 26 in the year of our Lord two thousand and twenty-three (February 26, 2023) at 11:30 o'clock in the morning (11:30 a.m.) with 33 members and friends in attendance.

Rev. Katherine Michie opened with prayer.

Meeting Opened

Additional Elders

Call for a motion that Lily Carrothers and Carol Huston be inducted as ruling elders made by Peter Grivich, seconded by Wayne Gregory. **Carried**

Meeting Adjourned until end of service.

Meeting resumed at 11:30am

Appointment of Recording Secretary

Peter Grivich nominated Maureen Tomchick to be the recording secretary for the meeting, seconded by Elizabeth Leitch. **Carried**

Adoption of Agenda

Call for additions to the agenda – none. Moved to accept the agenda as presented by Peter Grivich, seconded by Sharon Peckham. **Carried**

Adoption of Minutes

Adoption of April 24, 2022 Caradoc Annual Congregational Meeting Minutes, as circulated. The following motion is moved by Peter Grivich, seconded by Donnie Carrothers. **Carried**

Review and Adoption of Committee Reports, as circulated. Moved by Peter Grivich, seconded by Carol Huston to accept reports as written. **Carried**

Review and Adoption of 2022 Financial Reports, as circulated. Moved by Peter Evans, seconded by Frank Deruiter to accept the financial reports as written. **Carried**

Brian Huston identified the high level of detail within the budget reports, referencing a shortfall of \$44,000.00 which also reflects approximately \$15,000 in interest. Without the interest our deficit would otherwise reflect \$59,000.00 dollars. Some of this was offset by wage subsidy but

the combination of COVID closure eliminated building rentals and fundraising coupled with the amalgamation with Knox and no longer having cost sharing reduced our revenue overall.

Review of 2023 Budget

Brian Huston presented the 2023 Budget. The budget being presented is very similar to that of 2022. We reflect a modest income and the board considered the ways to put this together. Going through expenses and then identifying a target of our offerings at \$140,000.00 which is what would be needed to not run a deficit. It was determined to have an offering amount that was attainable which is set at \$80,000.00 which is a little more that previous year of \$74,000.00. It was also budgeted for full time minister but given we have a vacancy currently and have other costs we have kept this amount consistent as a result. Bottom line of 2023 is very similar to 2022 with a shortfall of \$60,000. Offset by interest as well. Specific lines shared with the congregation which typically garners some discussion is Mission and Outreach. Contained is the Local Benevolent Fund which reflects a slight increase from last year from \$1000.00 with an additional \$400.00 from Ladies Aid a total of \$1400.00. This budget reflects an increase up to \$3000.00. Also contained under this line is for a Syrian family of \$1000.00 at the request of Session. Presbyterian sharing also contained under Mission and Outreach an increase \$14,771.00.

Review and Adoption of 2023 Budget, as circulated. Moved by Peter Grivich, seconded by Janet Evans to accept the financial reports as written. **Carried**

Status on New Beginning – Session has submitted statistics to them and they will be sending out someone to look at the demographics, finances and the building itself. Then they will appoint a coach to do some planning for the future in small groups. Rev. Katherine has made it clear that we are ready to go and would like something happening as soon as possible.

Discussion arose about the need to consider looking at doing things a little different here and is a great topic for discussion when New Beginnings arrives.

Motion to accept all current members to stand as Trustees. Moved by Barb Bolton, seconded by Elizabeth Leitch. **Carried.**

Current Board of Managers: Brian Huston as Chair, Charlotte Gregory as Secretary, members include: Bob Gillies, Wayne Gregory, Jan Salomons, Janet McGugan, Darrell McComb. Brian Huston and Janet McGugan will co-chair the board of managers moving forward as Brian plans for his exit as Chair. Recognition and thanks to Dan Walker who has retired from the Board of Managers after serving for 32 years. In replacement of Dan Walker, there is the addition of Ron Leitch for 2023.

Motion to accept Board of Managers as presented: Moved by Brian Huston to accept as presented, seconded by Sharon Gillies. **Carried.**

Thank you to the Reverend Katharine Michie for covering as interim moderator during this time, which exceeded the initial 8 weeks. Rev. Katharine will continue on in this role.

Confirmation that moving forward where possible Caradoc Presbyterian Church will hold its annual meeting the last Sunday of February. Next year's meeting will be Sunday February 25, 2024.

Thanks to all those willing to work in all committee work and its members as well as choir leadership and members.

Session Report

Session wishes to express our sincere thanks and gratitude to everyone involved in our Church during the year 2023. It was a year in which we experienced some uncertainty about our future, but we were rewarded nonetheless with new energy that gives us encouragement for the future. Members and adherents have committed time and energy to ensure that we remain a caring and compassionate Church in our community.

Unfortunately, Reverend Michelle Butterfield-Kocis was unable to join and lead us in 2023 due to her continuing illness. Fortunately, we had consistency in the pulpit thanks to Reverend Art Hiley, Charles Middleton, and our interim moderator Katharine Michie. Reverend Hiley preached a sermon series entitled 'Heart to Heart: Married Life - God Style' in January and February of 2023. In December, Reverend John Bannerman began a 6-month contract position at ¾ time to minister to our congregation during Reverend Butterfield-Kocis' absence.

In January of 2023, our Church family came together to host a wedding for John Van Berkel and Brianne Allingham. The Sanctuary and Fellowship Hall were beautifully decorated and people from our congregation helped serve dinner. The Wedding Ceremony was performed by Pastor Doug Gillard who is a family friend.

In 2023 Carol Huston and Lily Carrothers agreed to serve on Session as Ruling Elders. Both had previously served as Elders, and they were once again inducted to Session.

On Saturday April 22, we had a 'Congregation Conversation' with Reverend Gord Brown and Mr. Gerald Stocking from Presbytery. Our interim moderator, Katharine Michie was also present at the meeting. During the meeting people were able to express their concerns regarding our future and leadership issues. Reverend Brown prepared a report to Presbytery outlining the information that he had gleaned from this conversation. Presbytery decided to investigate the possibility of Caradoc Presbyterian Church hiring a Minister as a 'Stated Supply Minister' considering the extended medical leave of Reverend Butterfield-Kocis.

In September, a search committee was formed to prepare a Job Description for the Stated Supply Minister Position and to begin the search. The Committee consisted of Reverend Keith McKee from St. George's Presbyterian Church in London, Peter Grivich, Lily Carrothers, and Jamie Hayter from Session. A Job Description was prepared and agreed upon by Session. Upon approval of the Job Description, the search began. We were looking for a Minister who would be able to commit to a 6-month contract at ¾ time, with the possibility of renewing the contract if all sides agreed. The Congregation was regularly kept up to date on the progress of the Committee. The Search Committee identified Reverend John Bannerman as a suitable candidate to fulfill the Stated Supply Contract Position and Session agreed with the decision. On December 1st, 2023, Reverend Bannerman began the contract with our Church. As a Church we are thankful to Reverend Bannerman and to all those involved in the process. It seemed appropriate and exciting to have Reverend Bannerman begin his time at CPC at the

beginning of the Advent Season. There was also a significant bump in attendance during December.

All through 2023 our Church has been working on the New Beginnings Program. The concept behind the New Beginnings Program is that the congregation could explore possible options and make informed decisions about the future of our Church. Reports were prepared, and on June 12th, 39 people from our congregation met with our New Beginnings assessor, Reverend Ken MacQuarrie from St. Catharines. Reverend MacQuarrie prepared an assessment of our Church. On October 26-28 we began our Transformation Weekend by meeting together on Friday evening. The meeting was led by our New Beginnings Coach, Karen Dimock from Ottawa, and Reverend Torrey Griffith from New London, Prince Edward Island. The small group facilitators who volunteered were Lily Carrothers, Joanne Grivich, Carol Huston, Sharon Peckham, and Betty Walker. After a training session, the facilitators began a series of small group meetings with members and adherents. We wish to thank all those who participated and volunteered throughout this process, and we are hopeful that our future story will glorify God and help our Church as we serve our community.

Music remains an important part of our ministry at CPC. We are led by our very talented accompanist, Rosemary Bannerman. Our choir has grown, and we have a great deal of fun and camaraderie while learning as well. Rosemary is very encouraging, but always challenges the choir to strive for improvement. On December 17th, the choir performed the Lessons and Carols Service. This service was well received by the congregation. On Friday November 24, we listened to a live concert performed by Peter Slofstra. Peter played the guitar and performed his own music. The music was inspirational and well received. Both people from the community and our congregation attended this performance.

As a Church we celebrated Communion on five occasions in 2023. The first Communion was on Palm Sunday, April 2 with Reverend Hiley officiating. We celebrated Communion once again on April 22 with Reverend Katharine Michie. Other Communion services were June 25 with Reverend Michie, and during our Thanksgiving Service on October 8th with Reverend Hiley. Our final Communion service of 2023 was held on the first Sunday of Advent, December 3rd, with Reverend John Bannerman.

We are thankful to have a Hungarian congregation also worship at our Church. This congregation is led by Reverend Ferenc Szatmari and the services are in the Hungarian language. They met several times throughout 2023 and regularly celebrated communion. Other special Sunday Services include our 170-year Anniversary Service on May 7, and our Church Picnic Outdoor Service on June 25th. We had ideal weather for our picnic, and we enjoyed food and games. On September 10, 2023, Knox Presbyterian Church's 155th Anniversary service was celebrated.

Our Sunday School program continued in 2023 thanks to the dedication of Elizabeth Leitch and the other teachers, Joanne Grivich, Sharon Peckham, and Betty Walker. At our Sunday School

Picnic, we were thrilled to see 11 children at that event. Our children also sang and performed a Christmas Pageant at our Lessons and Carols Service on December 17th. We rejoice in welcoming Lynda Strathdee, Joe and Kate Walsh, Dan and Jody Dunn and their families to our congregation in 2023.

The congregation mourns the loss of Dolores Lamont and Charles Beregi in 2023. Other members and adherents also suffered personal losses. We think of those family members as they grieve their loss.

Our congregation was very generous with Benevolence in 2023. We gave to a refugee family while also donating to the Salvation Army, The Caring Cupboard, and Women's Rural Resource Centre as well as other charities.

While 2023 did provide some challenges, we are encouraged for our future at Caradoc Presbyterian Church for we know that everything we do is for the Glory of God.

Board of Managers' Report

The Board oversees that maintenance of the Church building and grounds, organizes grass cutting, maintains insurance, coordinates elevator inspections, arranges water sampling and testing, snow removal, furnace maintenance, safety inspections, fire extinguisher servicing, offering envelopes, photocopiers, printers, computers, book-keeping and custodial staff. Specific tasks undertaken in 2023 were:

- Arranged annual furnace servicing
- General building and grounds maintenance,
- Arranging contracts for grass cutting, custodial duties and snow removal
- Reviewed financial reports, balance sheet and bank statements monthly
- Completing financial auditing tasks on a monthly basis
- Preparing the annual budget
- Quarterly water quality testing to conform with Health Unit requirements
- Painting the nursery room in basement
- Arranging for painting of the sanctuary steel roof
- Arranging for insurance coverage
- Maintaining church computers, printers and copiers
- Looking after annual elevator inspections and maintenance
- Added second projector to allow video display for choir
- Arranged spring yard sale and basement cleanup
- Completing monthly inspections of fire extinguishers and arranging annual fire safety inspections
- Monitoring operating cash flow with our bookkeeper and making requests to CPC
 Trustees for fund transfers to support our operating budget.

Operating Budget Summary 2023

Our tithes and offerings in 2023 were \$87,672, an increase of \$11,400 over 2022. Donations that were made to the Benevolent Fund, Presbyterian Sharing, PWS&D and the Kaba Family are in addition to the \$87,672.

Our expenses were significantly lower than budgeted, as we prepared the 2023 budget based on having a full-time minister. Our operating shortfall (operating income, less operating expenses) was -\$12,900. If we also include our interest income of \$15,246, we were slightly higher in our overall balance sheet.

New Beginnings – Small Group Facilitators Report to Congregation

As noted in the Session Report, through 2023 our Church has been working on the New Beginnings Program. The small group facilitators who volunteered were Lily Carrothers, Joanne Grivich, Carol Huston, Sharon Peckham, and Betty Walker. After a training session, the facilitators began a series of small group meetings with members and adherents. The following provides a summary of the small group meetings.

1. What we learned from this process about our congregation

The New Beginnings Process has shown us that we are a welcoming, generous, and passionate congregation. We are generally positive, and hopeful for the future of our congregation!

2. What we learned from this process about our community

Through this process, we have also learned that we don't really know what unmet needs there might be in our community in relation to the demographics shown in the assessment. Some groups, such as migrant workers, would not have been included in the census statistics. However, we are good at, and generous in collecting donations for other organizations who have the infrastructure and capability of distributing these basic supplies to the less fortunate. For example, the Caring Cupboard, Women's Rural Resource Center, and the Salvation Army to name a few.

New Beginnings – Cont'd.....

3. What consensus came from our Group Leaders meeting

The consensus among the group leaders is that all those who participated in the discussions were in favor of the future story that embraces Mission Redefinition. This will not likely be exactly as described in the hypothetical example in the assessment but will need to be defined by the congregation. We agreed that there needs to be more focus on reaching out to the surrounding community.

4. What next steps are implied by this decision?

It will be up to the members and adherents to define the mission and the mission field. Areas of ministry will need to be researched and plans developed to implement them.

4a. What 21-Day challenge did the Leaders decide to do?

As a first step to building community involvement, the leaders decided that our Church will hold a Free Chili Lunch, followed by an afternoon of Board Games and Cards. We plan to hold this event in the Fellowship Hall on February 10th, with lunch from 12-1pm, and games from 1-4pm. Hosting this event will require the assistance of many volunteers for advertising, set up, cooking, clean up, and transportation.

4b. Contact Hope Partnership of our decision to discover resources

This report will be forwarded to our Coach, Karen Dimock, and to Hope Partnership to inform them of our decision and to access resources to move forward with implementation.

Trustees Report

Respectively submitted by Maureen Tomchick, Peter Evans and Jan Salomons

We were able to make use of the "18 month Special" rate on a number of maturing investments and also made use of this rate when we transferred the Knox Frank Legacy Rate Optimizer GIC 4 from the Bank of Montreal to Mainstreet Credit Union.

The Trustees only needed to transfer \$12 500 from the Trustees holdings to the Church operating account to cover expenses early in 2023. As there was some uncertainty around future cash flow, maturing term #30 was cashed and held in the High Interest account. As no further transfers to operations was needed it allowed us to add \$24 500 to the balance of the Knox GIC when it was re-invested still leaving a supportable remainder in the High Interest account should transfers be required in the expected high expense period in the beginning of the year.

To clarify, the total Investment Income deposited into the High Interest account is lower than the interest earned due to a few terms compounding and the interest will only be available at maturity.

Appendix B – Pre-amble and Operating and	Capital Budget for 2024

Operating Budget Outlook 2024 - Preamble

The Draft 2024 budget as follows was prepared by the Board, with input from Session.

In preparing the 2024 Budget for Congregation approval, we have assumed a three-quarter time minister position, recognizing that could change during the year. We have also included our projected interest income in the budget, to provide the Congregation a better overall picture of our income and expenses. This is different than previous years, where we kept the interest income separate from our operating budget. We then increased our budget income to balance our overall budget. This would require an increase in our overall Givings from \$81,223 in 2023 to \$100,000 in 2024, to balance the budget.

The Board is in the process of obtaining quotes to illuminate and mount the stained-glass windows from the Knox sanctuary. We have not included these costs in the operating budget, but will bring a recommendation to Session and the Congregation for approval once we complete our investigation.

It is recommended that, in approving the 2024 Budget, the motion also include provision to "Allow the Board to request operational funds from the Trustees when and if necessary and for the Trustees to respond to in an appropriate manner."

The Board has also prepared a graph of historical annual Givings for North Caradoc St. Andrews and now Caradoc Presbyterian Church, included in Appendix C.


