REPORT OF THE HISTORY COMMITTEE:

The Synod Archives for many years was cared for by Summerside Presbyterian Church. With the demolition of that building in preparation for construction of a new church, the Archives was moved to First Presbyterian Church in New Glasgow, NS, under the care of Rev. Glen Matheson, D.D.

The Archives room at First, New Glasgow, houses four collections: archives material for the Synod of the Atlantic, the Presbytery of Pictou, as well as items from the host church – First Presbyterian, New Glasgow. A fourth collection, a large quantity of documents and photos concerning Camp Geddie, are in storage at the Archives but have not been organized or catalogued.

Over the past year the Synod Archives was used extensively by both the Archives and Art Gallery of Prince Edward Island in regards to researching the life of Rev. William Stuart (1837-1916). While serving in the Presbyteries of PEI, NB and Pictou before moving to New Jersey he was an accomplished artist, often painting scenes including early Presbyterian churches. His history and artistic skills were unknown to us prior to the research carried out this year by the PEI archivists using Synod Archives material.

At present there is sufficient storage space and shelving for Synod materials and no finances are required for the coming year. In an ideal world I would be receiving documents, photos, etc. from congregations within our Synod, but virtually no material has been donated to the Archives in recent years. I would welcome discussion with individuals or congregations should they consider donating items to the Synod Archives.

**Recommendation 13

That the report of the History Committee be received for information.

HOSPTIAL VISITOR

The 2018 Synod asked the Synod Council to review the position of Halifax Hospital Visitor.

The Council asked three Council members to do a survey of the Presbyteries asking them to comment on a) the value of the position, and b) to make suggestions about the nature of the position in the future if it is retained. Five of the six Presbyteries replied.

All were unanimous in expressing their appreciation of this ministry over the years. This ministry position is of great benefit to ministers who are a long way from the Halifax area and it means a great deal to patients and their families.

The Presbyteries were anxious to see the position continued.

Some suggestions were made in the replies; the Council will continue in the next year to review them as it looks at any changes that might be needed in the job description for this part-time position and at hospital requirements for the staff person in order for that person to have access to files and to be part of the team of chaplains. The suggestions included having a brochure and/or bulletin insert that congregations can use to publicize this position, clarification of arrangements for visitation when the staff person is on vacation or ill, a review of stipend, the denominational affiliation of the person chosen for this position, being sure that the job description includes provision of time for communication with clergy of the home congregations of patients within the requirements of the law relating to patient privacy, visibility among hospital staff and connections with other Spiritual Care staff.

Recommendation 14

That the part-time staff position of a Halifax Area Hospital Visitor funded by the Presbyteries on the current basis (presbyteries are billed according to the number of visits made to persons from each Presbytery) be continued.

Recommendation 15

That a Search Committee be appointed to review the Ministry Description for the Hospital Visitor and report to Synod Council, having power to issue.

Recommendation 16

That the Search Committee seek a new hospital visitor to the Halifax area and report to 2020 meeting of Synod.

Recommendation 17

That the Moderator name the Search Committee in consultation with the Local Support Committee.

SYNOD STAFF

Synod Camping & Youth Consultant:

The Synod Personnel Committee meets regularly with the Synod's Camping & Youth Consultant and is responsible for providing oversight in evaluating this ministry annually, and for working with the consultant to prepare and review future goals.

**Recommendation 18

That Whitney Canning, Camping and Youth Consultant, be given permission to address the court.

Hospital Visitor:

The Synod, at its 2018 meeting, empowered Synod Council to appoint an interim hospital visitor to the Hospitals in the Halifax Area. A search committee was appointed by the Council to seek an interim hospital visitor for 2019 and Council accepted its recommendation to appoint Calvin Burt. Calvin is a student for the Ministry within The United Church of Canada; he has extensive Clinical Pastoral Education. He is the part time student minister at Sharon

Presbyterian Church, Dean NS and at two United Churches in the Upper Musquodoboit, NS, Shared Ministry.

The Synod Personnel Committee received a report from the local Support Committee for the Hospital Visitor regarding the work of the interim-visitor, Mr. Calvin Burt. The local Support Committee reports that Calvin has been well received and that he has been diligent in fulfilling his responsibilities.

Recommendation 19

That Synod express its thanks to Calvin Burt for his work as interim hospital visitor.

Recommendation 20

That, recognizing the continuing need for interim hospital visitation in Halifax while the search takes place for a new hospital visitor, Mr. Calvin Burt be appointed the Synod Hospital Visitor in the Halifax area for a period of I year (i.e. January I, 2020 – December 3I, 2020).

ASSESSOR PRESBYTERS:

Recommendation 21

That Synod appoint two Assessor Presbyters to the Presbytery of Newfoundland with vote, Charles McPherson and Ian Ferguson.

MOTION TO RECONSIDER:

The Synod passed recommendation 3 of the Mission Committee Report during the 2018 Annual meeting. The recommendation was "that The Atlantic Ministry of the Deaf receive \$1,000 for 2019 and that we request provision of a financial statement by June 30, 2019 if funding support beyond 2019 is to be considered" (*The Synod of the Atlantic Provinces Minutes & Reports*, 2018, p. 9 & 56).

Financial statements have not been received and therefore the Missions committee will not be including a recommendation that The Atlantic Ministry of the Deaf receive funds for 2020.

When Synod Council meet on 2 October 2019 the members were informed that the cheque had yet to be sent for 2019. The Council was also informed that The Atlantic Ministry of the Deaf had lost its charitable status. Given the information that has come forward, Council does not believe it would be good stewardship on our part to give \$1,000 to an organization that cannot produce financial statements and has lost its charitable status.

Recommendation 22

That Synod reconsider Recommendation 3 of the 2018 Mission Committee Report regarding our donation to The Atlantic Ministry of the Deaf.

FINANCES:

In 2018 the Synod Task Group proposed a new method of determining grants for all the camps within the Synod, which was adopted at the 2019 Synod, the move towards this new funding methodology continues to be reflected in the 2020 budget. The model we are now using examines how much revenue comes to Synod from each Presbytery, and what our total

expenses on Camping are as a Synod. The Total used for camping is then sent to the camps in the same proportion. For example, PEI contributes more to Synod than Cape Breton, so Camp Keir has a higher target than Camp MacLeod. Camp Geddie receives the portion from any Presbytery without a camp of their own. The process of transitioning to the new funding levels aims to limit the change in funding to a \$5000 shift per year, resulting in the new model being fully implemented in 2024.

When looking at the Geddie Grant in 2024, it appears smaller than Keir. The actual grant itself remains the largest, the figure in the budget has the Geddie Executive Director portion of the Camping and Youth Consultant position and the Insurance Check already removed from this figure. The details of how these figures are derived can be found on the "Testing Camp Targets" Financial Sheet.

It is worth noting that these targets for camp funding, being based on Presbytery Dollar Base, will themselves shift from year to year as the Dollar Base itself moves. For that reason round numbers are used as 2024 targets, these are revaluated annually, to ensure that the results remain in line with the goal of proportional funding. There was a shift between the 2017 and 2018 dollar base, but not so much as to change the 2020 budget with regards to the shifts towards final targets implemented this year.

A multiyear trend of downward Dollar Base was reversed in 2018, changing from projected budget with still significant deficits, to posting a potential significant surplus in 2021. While this is encouraging, it remains to be seen if this swing of over \$20,000 in revenue is a new normal, or an anomaly. This uncertainty has resulted in not changing the projections beyond using the current year as the starting place.

Recommendation 25

That Synod apply for a 2020 Regional Resourcing Grant in the amount of \$45,000 to help fund camping ministries within the Synod.

Recommendation 26

That the Synod dues for the year 2020 be set at a rate of 2.0% of the dollar base figure reported in the Acts and Proceedings of the 2019 General Assembly.

Recommendation 27

ELECTION OF SYNOD MODERATORS:

During the 2018 meeting of Synod the method of electing the Moderator for Synod was discussed and the following motion was adopted (2018 Synod Minutes, p. 11): "P.A. McDonald moved, duly seconded, that Synod Council study ways to improve the manner in which the Synod elects the Moderator."

After considering ways to improve the election of the Moderator, the Council makes the following recommendation:

Recommendation 28

That the Synod adopt the following method for electing the Moderator before the annual meeting: (1) Presbytery Nominations for Moderator be sent to the clerk by April 30, (2) Ballots for Moderator be sent to the Presbyteries after the May meeting of Synod Council and returned by September 30, (3) Synod Council count the ballots at its October meeting.

TASK FORCE:

The Synod Working Group (Task Force) was appointed in 2017 to discuss and implement changes to Synod beginning with the 2018 annual meeting. This group was also tasked with exploring funding/cost sharing options for all expenses related to the Synod Camp and this led to the new funding strategy implemented in 2018.

Council received many feedback forms from the members of Synod after last year's meeting. The feedback was overwhelmingly positive and there was a few helpful constructive comments to help improve on some things going forward and most of these suggestions have been implemented for this year.

The Council believes that the work of the task force is completed and recommends that this working group be dissolved.

Recommendation 29

That the Synod Working Group (Task Force) be dissolved with the thanks of the court.

SYNOD MEETING 2020 & FUTURE MEETINGS

Billets: At its last meeting, the Council discussed the matter of offering billets during Synod meetings. Given the challenges that this presents for host churches and also with respect to *Leading with Care* we question if it is appropriate for the Synod to offer billets and believe it is time to discontinue this practice.

Recommendation 30

That the practice of using billets for Synod meetings end as of 2019 and that members of Synod offer feedback to Synod Council with suggestion for alternatives to billeting.

Recommendation 31

That the Rev. Dr. Richard Topping, Principal of VST be invited to be the guest speaker for Synod 2021.

SYNOD SPEAKER FOR 2021 – Rev. Dr. Richard Topping

Richard Topping received his Bachelor of Arts degree in Religious Studies from University of Waterloo, a Master of Arts in Theology from St. Michael's University in the Toronto School of Theology and a Doctor of Philosophy in Theology from Wycliffe College, where his thesis Director was Professor John Webster.

Richard was Minister at Zion and Knox Presbyterian Churches in Muskoka, Ontario from 1993-1996 and at the Church of St. Andrew and St. Paul in Montreal, Quebec, where he was Assistant Minister from 1997-1999 and Senior Minister from 2000-2009. He has written or coauthored a number of documents for the Presbyterian Church in Canada, including a *Catechism for Today* (2008)

and *Together in Ministry* (2006). He currently serves on the Church Doctrine Committee for the national church.

Richard taught at Presbyterian College (2001-2009) in the Montreal School of Theology at McGill University in the areas of Preaching, Pastoral theology, Introduction to Ministry and Church, Ministry and Sacraments. He has supervised a number of students in their in-ministry year.

Richard holds the St. Andrew's Hall Chair in Studies in the Reformed Tradition. He teaches in the areas of Introduction to Theology, Reformation History, Christian Spirituality and Reformed Theology of the 19th and Twentieth Century. He has also lectured at Regent College in the area of Theology and Proclamation. He has published in the areas of theological hermeneutics, homiletics, philosophy of religion, systematic theology and the theologies of John Calvin and Karl Barth. His current projects include two edited collections of essays, one a set of papers presented in 2009 on the occasion of the 500th anniversary of the birth of John Calvin and the other a series of catechetical essays entitled, Welcome to the Church. He is also working on a book which examines the role of the imagination in postmodern theology.

Richard is a participant in the Vancouver New Testament Colloquium and initiated a Karl Barth reading group at St. Andrew's Hall. He is a regular preacher in the Vancouver area and lecturer across the country in the areas of pastoral leadership and strategic direction.

Independent Auditor's Report

To the Council of The Synod of the Atlantic Provinces

Opinion

Notes to the Financial Statements

December 31, 2018

1. DESCRIPTION OF OPERATIONS

The Synod of the Atlantic Provinces (the "Synod") is a court of the Presbyterian Church of Canada which oversees and supports presbyteries, congregations and joint ministries in the Atlantic Provinces. The Synod is a registered charity and is exempt from income taxes.

The Synod provided administrative services for a prison outreach program operated by the Presbytery of Halifax – Lunenburg. Expenses were netted against program funding from the Province of Nova Scotia and had no effect on the statement of operations and changes in net assets. These administrative services ended on February 11, 2019.

2. ACCOUNTING POLICIES

The financial statements have been prepared in accordance with Canadian accounting standards for not-for-profit organizations in Part III of the CICA Handbook and include the following significant accounting policies:

Revenue recognition

The Synod uses the deferral method of accounting for revenue. Under the deferral method of accounting, restricted contributions related to expenses of future periods are deferred and recognized as revenue in the period in which the related expenses are incurred. Unrestricted contributions are reported as revenue when they are received or receivable, if the amount to be received can be reasonably estimated and collection is reasonably assured.

Cash and cash equivalents

Cash and cash equivalents represent amounts on deposit and short-term investments with a financial institution with maturities of three months or less.

Trust funds

Trust fund investments are primarily comprised of guaranteed investment certificates. Interest rates range from 0.40% to 1.95%.

Contributed services

Volunteers contribute their time to assist the Synod in carrying out its services and programs. Due to the difficulty of determining their fair value, these contributed services are not recognized in the financial statements. Contributed services or amounts where a fair value can be determined are recorded in the financial statements. In the current year \$Nil (2017 - \$Nil) of contributed expenses were recorded.

Financial instruments

The Synod initially measures its financial assets and financial liabilities at fair value. It subsequently measures all of its financial assets and financial liabilities at amortized cost.

2. ACCOUNTING POLICIES (continued)

Financial instruments (continued)

Transaction costs related to financial instruments measured at fair value subsequent to initial recognition are expensed as incurred. Transaction costs related to other financial instruments are added to the carrying value of the asset or netted against the carrying value of the liability and are then recognized over the expected life of the instrument using the effective interest method.

Use of estimates

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the reporting date of the financial statements and the reported amounts of revenues and expenses at the reporting period. Significant estimates used in these financial statements include the allowance for doubtful accounts receivable, and certain accrued liabilities. Actual results could differ materially from those estimates. These estimates are reviewed periodically and adjustments are made, as appropriate, in the statement of operations in the year they become known.

5. PENSION PLAN

The Synod is a member of The Presbyterian Church in Canada Pension Plan which was established to provide retirement income for eligible individuals. The plan is a contributory multi-employer defined benefit pension plan. The Synod has accounted for this pension plan as a defined contribution pension plan because sufficient information is not available to use defined benefit plan accounting. The Synod recognizes the contributions required to be made under the plan as an expense. Total combined employer and employee contributions for the year were \$11,318 (2017 - \$10,657).

6. RELATED PARTY TRANSACTIONS

Transactions with the Presbyterian Church of Canada, presbyteries, congregations and joint ministries are recorded at the exchange amount. The relationship of the bodies is disclosed in Note 1.

7. FINANCIAL INSTRUMENTS

Fair value

The fair value of cash and cash equivalents, accounts receivable, and accounts payable and accrued liabilities approximates their carrying value due to their relative short-term nature. The fair value of trust fund investments approximates their carrying value due to the nature of the investments.

Credit risk

The Synod performs an evaluation of accounts receivable and records an allowance for doubtful accounts as required. At December 31, 2018 the allowance for doubtful accounts, which offsets accounts receivable, was \$18,743 (2017 - \$9,767).

Interest rate risk

The cash equivalents and trust fund investments bear interest at fixed rates. Consequently, the cash flow exposure is not considered to be significant.

7. FINANCIAL INSTRUMENTS (continued)

Liquidity risk

The Synod's objective is to have sufficient liquidity to meet its liabilities when due. The Synod monitors its cash balances and cash flows generated from operations to meet its requirements. Given the Synod's currently available liquid resources, as compared to its contractual obligations, management assesses the Synod's liquidity risk to be low.

PROGRAMME COMMITTEE

PAYS (Presbyterian Atlantic Synod Youth) took place at Camp Geddie, Merigomish, N.S., on the weekend of May 24-26, 2019. The Camp Geddie summer staff of 2019 provided recreational and community building leadership. We had 32 youth representing PEI, New Brunswick, Halifax-Lunenburg and Pictou Presbyteries. We had 10 adults representing PEI, New Brunswick, Pictou and Halifax-Lunenburg Presbyteries. The Camp Geddie staff of 21 young adults added to our energy and excitement.

Rev. Cate Ratcliff, an Anglican Priest in Eastern Passage, was our youth speaker who focused on the "Fruits of the Spirit" exploring Galatians 5. Cate did two sessions with the youth, exploring how the "fruits of the spirit" take shape in their lives. A new addition to PAYS this year was an adult workshop on the Friday evening and Saturday morning of the weekend event. Dave Csinos, an Assistant Professor of Practical Theology at Atlantic School of Theology in Halifax, was our adult speaker. Dave also serves as founder and president of Faith Forward, an ecumenical organization for innovation in ministry with children and youth. He did a workshop on 'Four Ways of Knowing God: Nurturing Faith through Spiritual Styles' which explored four distinct avenues for connecting with God: through words, emotions, symbols, and action. The second workshop, 'Children's Ministry in the Way of Jesus, offered participants the opportunity to explore a new path forward in our efforts to cultivate spiritual vitality in children and youth. The feedback on this new portion of PAYS was very positive and participants enjoyed the opportunity to reflect and share as youth leaders while still participating in the PAYS weekend with the youth.

Along with having the Camp Geddie staff lead much of PAYS and a new adult education portion to the weekend, we also tried another new endeavour and had Geddie Spageddie (a spaghetti meal fundraiser) on Saturday afternoon. This gave the PAYS participants a chance to meet and enjoy fellowship with the wider community. Given that PAYS was not hosted at a church, Geddie Spageddie offered an opportunity to connect the youth with the supporting community as is often done when PAYS is hosted by a church. Many folks expressed a sense of gratitude for creating a time of fellowship with a larger community which has a heart for youth ministry. Many connections and renewal of old connections were made over the traditional Geddie Spageddie meal.

On behalf of those present for PAYS, thank you for your commitment to this unique event. Your financial and prayerful support are greatly appreciated and model a leadership of care, compassion and generosity to the young people and adults involved.

During the 2018 Atlantic Synod, four workshops were presented for those attending Synod. They proved to be very popular and helpful. As a result, Synod Council decided to have the workshop format again this year. The Programme Committee worked on obtaining workshop leaders for the 2019 Synod. We are very grateful that the workshop leaders we approached were more than willing to come to Charlottetown and present the workshops. Thank you!

MISSION COMMITTEE

The Synod Mission Committee held a Teleconference meeting on September 19th.

The Committee requested proposal for grants last year. Three proposals were received and all three were approved for funding in 2018 as follows:

- Bridges to Hope, St. John's, NL for \$500 grant for the ongoing work at Brides to Hope. The money was received and was acknowledged.
- The Presbyterian Church of Saint David, Halifax for funding in the amount of \$2,000 towards the New Beginnings Missional Transformation, Community Consultation Phase. The money was received and acknowledged. A copy of the findings of the New Beginnings Community Consultation was received.
- Kensington Presbyterian Church, PEI on behalf of the Kensington New London charge for funding in the amount of \$500 towards the K-D Lunch Outreach for Kensington Intermediate and Senior High (KISH) Students. Equipment was purchased to prepare and serve the lunch. In the spring of this year only the Intermediate Students attended, although the invitation was for all the students. This fall Senior High students are starting to attend. The churches are looking at expanding the outreach and having a lunch for seniors.

In 2019 the following have been funded:

Coverdale Courtwork Society of Halifax \$3,000 Coverdale Centre for Women Saint John, NB \$3,000

At Synod last year there was a motion with respect to Coverdale Courtwork Society of Halifax and Coverdale Centre for Women, Saint John as follows:

D. Griffiths moved, duly seconded, that the funding for Coverdale Courtwork Society of Halifax and Coverdale Centre for Women, Saint John be phased out over the next three years.

Motion to Refer: P.A. McDonald moved, duly seconded, that the matter be referred back to the Mission Committee. Adopted.

The Committee considered the referral and confirmed its earlier position as follows:

The work of the committee will be guided by Living Faith 9.1.3 "Mission is service, a call to help people in need and to permeate all of life with the compassion of God." A major focus of the committee will be to encourage local mission initiatives while making the best use of available Synod resources by:

- being a catalyst to promote mission ideas and projects within the Synod
- > providing examples of mission projects used in other congregations, presbyteries and synods to spark ideas for mission in our congregations and presbyteries
- providing funds for starting or expanding local projects by congregations and/or presbyteries within the Synod
- providing funds on a case-by-case basis for youth and others taking part in PCC sponsored Mission trips (eg. YIM). Participants would normally agree to make at least

one presentation about their learning to interested meetings of congregations, AMS, Presbytery or Synod.

The Committee recognized the important work of the Coverdale Courtwork Society of Halifax and Coverdale Centre for Women, Saint John. Both of these have been funded for a considerable period of time. It is recognized that the Presbyterian Church was instrumental in the early start-up of these two organizations. They are have both grown and expanded their services and are funded by numerous groups and receive governmental funding for some of the work that they do and are deemed to be self-sufficient. The Committee feels that with the limited funds available through Synod, that it is time to phase out the funding to these two groups and start to initiate other opportunities that throughout the Synod.

In order to encourage local mission initiatives while making the best use of Synod resources the Committee decided to move towards phasing out financial support of organizations deemed to be self-sufficient, and use the funds to assist congregations and presbyteries in new or expanded initiatives in mission. Funds will be available to assist with local mission projects on a one time basis in the form of seed money or catalyst to start a project or expand an existing one. We are inviting suggestions for possible projects that would involve one or more congregations within the Atlantic Synod. A letter along with application forms will be sent out to the presbyteries in October.

The Rev. Beth Mattinson is involved with the Atlantic Ministry of the Deaf. She is very positive about the ministry they provide which works to provide services wherever needed, but the work is limited by lack of finances. Unfortunately we did not receive a financial update this year despite requesting one. No financial statement was received for 2018, so funding was reduced to \$1,000. The Committee was also informed that this Ministry has lost its charitable status. For these reasons, there is no recommendation with respect to ongoing funding.

Recommendation 2: That Coverdale Centre for Women, Saint John receive \$2,000 for 2020 with the intention of phasing out this grant over the next two years.

Recommendation 3: That the budget for the Synod Mission Committee for all mission projects be \$11,500 for 2020.

ATLANTIC MISSION SOCIETY

The Purpose of the Atlantic Mission Society is to glorify God and support with prayer, study and service mission endeavours through The Presbyterian Church in Canada

The Atlantic Mission Society (AMS) continues to be an active vibrant group of men and women working for mission in the Atlantic Region. There are 512 Members and 147 Associate Members in 62 Auxiliaries throughout six Presbyterials.

The 143rd Annual Meeting of the AMS was hosted by Miramichi Presbyterial in Sept 2019. Meetings were held at the United Church Centre in Miramichi with the closing Communion service and induction of Officers being held during the Sunday worship service at Calvin PC. Worship and Communion were led by the Rev. Ross Wiseman; the induction of Officers by the Rev. Derek Krunys. Luncheon was provided by Calvin Presbyterian Church. The theme for the weekend was "Here I am, Lord" based on Isaiah 6:8. Our guest speaker was Becky Bauman, an Occupational Therapist from Orillia, ON, who spoke about the two years her family spent in Nepal as part of a mission project of the PCC. Beginning in February 2017 her husband, Nicholas Bauman, a surgeon, taught and worked at the Tansen Christian Mission Hospital. Their three children went with them, and their daughter Dorothy (Dot) was born during their first year in Tansen. Becky volunteered at The New Life Psychiatric Rehabilitation Center. In Nepal, people with disabilities and mental illness are shunned by their families and the community. The Center provides a safe place for them to live, be supported, and learn life skills. Becky spoke from her heart and attended all the sessions. She made herself available for conversations or to answer questions throughout the weekend and on Sunday gave a wonderful presentation to the children during closing worship. Dot brought energy and joy to every event and endeared herself to all the members present. The AMS 20/20 Project is a two year project to help expand the programs of the New Life Center.

Guy Smagghe, Director of Presbyterian World Service and Development (PWS&D) was our second guest speaker. He spoke with passion about the projects and ongoing work of PWS&D with a slide presentation.

Ian Ross-MacDonald, General Secretary, Life and Mission Agency provided an update on the new Mission Study to be released soon, and introduced the 2020 calendar "Celebrating Children and Youth" featuring art work by children. He also updated us on the *Presbyterian Connection* newspaper and *Gifts of Change* catalogue. He expressed his appreciation for the work of the AMS and how much he enjoys attending the annual meeting.

We learned with regret that the WMS will cease to publish "Glad Tidings" at the end of this year. That leaves "The Message", produced by the AMS, as the only Mission publication in the PCC. We encourage all congregations and individuals to support the Message as an important outreach of our church.

At the annual meeting a new President and Vice-President were installed for three year terms. Our President is Rob Griffiths from PEI Presbyterial; Vice-President is Carol Stymiest from Miramichi Presbyterial. Besides duties to the AMS, the President serves on Synod Council and committees of Synod and is a member of the Life and Mission Agency of the National Church. The Vice-President serves on Assembly Council of the National Church.

The AMS continues to support overseas mission projects as well as many projects here at home. We continue to support the National Church, the three Atlantic camps and provide up to four bursaries to students studying for ministry.

The AMS is a busy group of women and men learning, praying and seeking to share Christ's love as we do God's work.

Bean Bursary** Eligibility (a) Students for the Ministry of The Presbyterian Church in Canada from the Synod and certified by one of the Presbyteries of the Synod, (b) Overseas Students (they could be ordained) having some connection with the Board of World Mission studying at one of the Colleges of our Church, (c) Students from other Synods certified by a Presbytery of our Church.
- **3. Ross Millar Bursary** Eligibility An undergraduate in Arts at Dalhousie University who "is qualifying himself for the ministry of the Presbyterian Church in Canada", to be awarded by the Board of Governors of Dalhousie on the recommendation of Synod.
- **4. David Wark Bursary** Eligibility Any student from this Synod in either Arts or Theology studying intramurally at a Canadian institution in preparation for the Ministry of our Church, with a preference for a candidate from any congregation in New Brunswick.

- **6. Margaret MacDougall Bursary** Eligibility A student who is preparing for full-time service in the Presbyterian Church in Canada with preference being given to students from within the Atlantic Synod. For information re Bursary 7 write the Clerk of the Presbytery of Cape Breton.
- 7. Roderick MacLeod Trust Eligibility Candidates from the Presbytery of Cape Breton

For information re Bursaries 8 through 11 write the Clerk of the Presbytery of Pictou.

- 8. Dr. Robert Johnston Bursary Eligibility (a) Students in Arts or Theology who are certified to Knox or Presbyterian Colleges or the Vancouver School of Theology whose communicant membership is in a congregation within the Presbytery of Pictou. APPENDIX D

SYNOD CAMPING STRATEGY

Historical Overview:

Camp Geddie:

In 1943, a special committee for Sabbath Schools and Young Peoples Society was appointed by the Synod to discuss the formation of a Synod Camp believing that camping was an effective means of Christian Education and spiritual growth for youth. The first Synod Camp was held at Camp Roderick at Sunnybrae, Nova Scotia in 1944. In that same year a former lobster factory/dance hall and 5 acres were purchased in Ponds, Nova Scotia (the heart of the current site of Camp Geddie). Children and youth attended from all over the Synod.

The ministry context of these decisions was a growing vision to augment the Sabbath School and Congregational youth programmes with camping experiences. That vision also gave birth to congregational camps throughout the Atlantic Provinces in places like Campbellton, Sunny Corner, and St. John, New Brunswick, St. John's, Newfoundland and Sunnybrae, Nova Scotia, to name a few. Presbytery camps also developed in Prince Edward Island and Cape Breton.

The facilities have seen significant development over the years with the building of individual and double cabins and the Margaret McDougall A Frame Lodge through the completion of the Irwin Lodge in 1989, a new crafts hall, a new washing facility, a new infirmary, new cabins, and a new marina to host the canoe programme. In 1990 an additional 10.5 acres were purchased.

With the completion of the winterized Irwin Lodge in 1989 a new phase of ministry was opened in winter retreats for organizations and congregations of the Synod. During this period and into the next two decades the focus of staffing at the camp changed. Young people, aspiring to further education were seeking paid employment and were not available for volunteer positions. Gradually government grants became available to assist with this expense but there was also a need to increase the financial commitment of the Synod to address this need.

In the late 1990's the need for an executive director was identified. This grew into an inclusion of this responsibility within the ministries of Synod Staff and eventually the Synod Youth and Camping Consultant.

Camp MacLeod:

It was during the post-war period (around 1945) that at least one minister in the Presbytery of Cape Breton advocated for a camp for Presbyterian young people within the Presbytery. By the early 1950s a camp was purchased from a Sydney service organization who had run the facility as a camp for under-privileged children. The first camp was held in either 1952 or 1953 under the Presbyterian banner. The camp has operated under the Presbytery of Cape Breton from its inception to the present.

A significant driving force for the creation of the camp was to provide a Christian camping experience for Presbyterian youth of the Presbytery that could be easily accessed. Realistically today, the campership, and staff, is made up participants from a variety of denominational backgrounds, and even no church background. Part of its current philosophy is to be an outreach in Christian community and faith to those who attend. We acknowledge the considerable financial support the Presbytery of Cape Breton provides for Camp MacLeod.

In these times few youth have available parents or guardians who are willing to drive to Camp Geddie from Cape Breton so this seems to be "a barrier" for participation at Camp Geddie.

Camp Keir:

Presbyterians have led the way in regards to camping ministry on the Island. While the Island currently has 5 Christian camps, Camp Keir is the longest running. It had its origins in 1947 when Rev. Jim McGowen, who was serving in Kensington at the time, bought some property in French River for the purposes of establishing a Presbyterian camp for our young people here on the Island. At the time, it was felt that sending our youth to Camp Geddie was not a feasible option for Island parents. The reasons for this were two-fold: first the travel and expense of transporting children back forth was unrealistic, and at the time Geddie was always running near full capacity.

As the years progressed, things began to change. A change in the ocean currents resulted in a much less appealing swimming situations and the numbers of those enrolling in our camps continued to decline.

These challenging circumstances caused presbytery to re-examine its camping ministry. It was proposed by some that a change of location might be the catalyst to breathe new life into our camping ministry. Land was purchased in Canoe Cove. During this period the Canoe Cove Church and the Charge of Central Parish really took hold of things and were integral in the operation and ongoing maintenance of the new building(s).

Funding and Accountability:

Camp Geddie:

The camp is owned and operated by the Synod of the Atlantic Provinces, with oversight provided by the Synod's Camp Geddie Committee, which reports to the Synod council and the Synod. The camp is accountable to the Synod, which receives annual reports of its ministry and finances. While funding for the camp comes from various sources the Synod does contribute a significant portion to support its camp.

Camp MacLeod:

Financially, each congregation is assessed by the Presbytery on a per household formula on an annual basis. There are also opportunities to make special contributions. The last several years the camp committee has initiated a pantry drive for designated food items. Last year there was a "wish list" circulated among the congregations for needed up grades to equipment at the camp. Some congregations provide camperships for their youth to attend; the camp does have a campership fund that was initially set up through a bequest at Bethel, Sydney. It is the Presbytery that oversees the operation of this camp.

Camp Keir:

The Camp does its own fundraising. Congregations are encouraged to support it as well by mean of fundraising and donations. We acknowledge the considerable financial support the Presbytery of Prince Edward Island provides for Camp Keir.

It is the Presbytery that oversees the operation of this camp.

Synod's Current Camping Strategy:

All the Camps within the Synod grew out of a calling to augment and support Christian Education among our young people. It is clear that while this focus on Christian Education continues, the camps note that this calling includes more than "our" Presbyterian young people as the camps offer Christian witness to young people from different denominations and from no church affiliation.

As stated in the historical overview the synod founded, and continues to own and operate, Camp Geddie to be a means of Christian education, spiritual growth and leadership training for our young people coming from various presbyteries, denominations and non-church back grounds within Atlantic Canada. The Synod also offers a camping experience to young people in presbyteries that do not have a presbytery camp. The Synod also offers an opportunity for young people to camp with people from other presbyteries, an experience which is continued in our synod youth events.

The Synod employs a Camping and Youth Consultant who serves as Executive Director of Camp Geddie to oversee and participate in the operation, administration, and promotion of the Synod Camp. The Executive Director provides direction and pastoral care to the campers and staff to promote the building up of young people in their relationship with Christ and each other. Given that it is not feasible in many cases for young people from PEI and Cape Breton to attend Camp Geddie these presbyteries have "filled a gap" by offering a more accessible means for Christian education through camping within their bounds. While Camp Keir and Camp MacLeod are not owned by nor held directly accountable to the Synod the Synod offers support to these camps recognizing their vital role in extending the camping opportunity in locations more accessible and feasible.

To offer support to Camp Keir and Camp MacLeod the Synod includes within its budget a grant for each camp. Furthermore, the Synod has assigned to its Camping and Youth Consultant the tasks of promoting camping ministry to the Synod, which would be inclusive of Synod and Presbytery Camps. The Synod also calls upon its Camping and Youth consultant to be a resource to Camps Keir and MacLeod and provide training.

APPENDIX E

MINISTRY DESCRIPTION Camping and Youth Consultant

This is a full-time contract position.

Duties include:

The Camping and Youth Consultant will serve as Executive Director of Camp Geddie, the camp of the Synod of the Atlantic Provinces. In that role s/he will:

- Oversee and participate in the operation, administration, and promotion of the Synod camp
- Serve as an ex officio member on the Camp Geddie Committee, and its sub-committees
- Provide for pastoral care for campers and staff

(For details of duties and responsibilities see the Job Description for Camp Geddie Executive Director)

- The camping and Youth Consultant will promote camping ministry to the Synod.
- Training for Youth leaders
- Synod youth events
- Be a resource person to Camp Keir and Camp MacLeod for equipping, support and training
- Personal contact with congregations
- Advisor to Presbytery Youth Events
- Train and lead congregational youth events.
- Work on Presbytery youth event, Synod youth events, and congregational youth events.
- Foster and maintain open communication with youth and parents

Education:

- University degree, preferably in a field relevant to the position.
- Theological education or other preparation for minister within the Reformed tradition is required.
- Ordination or Designation to the Order of Diaconal Ministries is desirable, but a candidate with relevant qualifications and experiences who is prepared to function in a ministry role, subject to appropriate structures of accountability and disciplines, will be considered.
- Training and/or experience in Programme Development.
- Knowledge of and compliance with the Presbyterian Church in Canada's policy to ensure the safety of children, youth and vulnerable adults ("Leading with Care").

Qualifications:

- Some camping and youth experience
- Ability to work in a team environment
- Strong interpersonal skills
- Some teaching experience
- Skills in Planning and Time Management
- Complete and up-to-date Child Abuse registry and Criminal Record checks
- Good computer skills/web use
- Conflict resolution
- Ability to lead a variety of age groups in a common task
- Membership in good standing in a congregation of the Presbyterian Church in Canada, or on a Roll of a Presbytery (Qualified candidates from other branches o the Reformed Tradition

- Knowledge of the polity and practices of the Presbyterian Church in Canada

Accountability and Consultation:

- The Camping and Youth Consultant will be supervised by the Personnel Committee of Synod, and will report to Synod Council through the committee
- The Camping and Youth Consultant will be an ex officio member of the Synod Programme Committee with voice but no vote.
- If an Ordained Minister or Diaconal Minister, the Camping and Youth Consultant will be a member of the Presbytery in which she or he resides.
- The Camping and Youth Consultant will be subject to an annual review of performance and ministry, conducted by the Synod Personnel Committee
- The Camping and Youth Consultant will be employed under the Human Resources Manual of the Synod.

Compensation:

Stipend and allowances are commensurate with experience and ecclesiastical status (ordained, diaconal, lay). This position is funded by the Synod of the Atlantic Provinces and is subject to the categories and rates of compensation regulated by the General Assembly.
