The Rev. Dr. Ernest Van Eck



Professor Ernest van Eck (MA [Greek]; DD) is the Principal of Knox College, which is part of Toronto Theological School, affiliated with the University of Toronto. Professor van Eck was previously associated with the Department of New Testament and Related Literature, Faculty of Theology and Religion, University of Pretoria, where he served as Department Head and Deputy Dean: Research and Postgraduate Studies. Professor van Eck is the author of 50 and co-author of 44 scholarly articles, published 12 chapters in academic books, and is the author of 2 monographs. In his research, he focuses on the socio-scientific and ideologically critical interpretation of the parables of historical Jesus, gender studies, sexuality in ancient texts, the Gospels, Paul, postcolonial hermeneutics, the anti-imperial interpretation of the New Testament, narratology, and other literary theories. Professor van Eck has been the assistant editor of HTS Theological Studies since 2020 and carries a B-rating from the South African National Research Foundation.

The practitioner performs procedures, primarily consisting of making inquiries of management and others within the entity, as appropriate, and applying analytical procedures, and evaluates the evidence obtained.

The procedures performed in a review are substantially less in extent than, and vary in nature from, those performed in an audit conducted in accordance with Canadian generally accepted auditing standards. Accordingly, we do not express an audit opinion on these financial statements.

1. Purpose of the Synod

The Synod of the Atlantic Provinces (the "Synod") is a not-for-profit organization incorporated provincially under the Societies Act of Nova Scotia. As a registered charity the Synod is exempt from the payment of income tax under Section 149(1) of the Income Tax Act.

The Synod of the Atlantic Provinces (the "Synod") is a court of the Presbyterian Church of Canada which oversees and supports presbyteries, congregations and joint ministries in the Atlantic Provinces.

2. Summary of significant accounting policies

The financial statements were prepared in accordance with Canadian accounting standards for not-for-profit organizations (ASNFPO) and, in management's opinion, with consideration of materiality and within the framework of the following accounting policies:

Cash and cash equivalents

Cash and cash equivalents represent amounts on deposit and short-term investments with a financial institution with maturities of three months or less.

Contributed services

Volunteers contribute their time to assist the Synod in carrying out its services and programs. Due to the difficulty of determining their fair value, these contributed services are not recognized in the financial statements. Contributed services or amounts where a fair value can be determined are recorded in the financial statements. In the current year \$nil (2021 - \$nil) of contributed expenses were recorded.

Revenue recognition

The Synod of the Atlantic Provinces follows the deferral method of accounting for contributions.

Under the deferral method of accounting, restricted contributions related to expenses of future periods are deferred and recognized as revenue in the period in which the related expenses are incurred. Unrestricted contributions are reported as revenue when they are received or receivable, if the amount to be received can be reasonably estimated and collection is reasonably assured.

Investment income is recognized as revenue when earned.

Trust funds

Funds held in trust are comprised of guaranteed investment certificates with interest rates ranging from 0.40% to 3.15% and funds invested with an investment portfolio managed by The Trustee Board of the Presbyterian Church in Canada.

Measurement uncertainty

Certain amounts in the financial statements are subject to measurement uncertainty and are based on the Synod's best information and judgment. Actual results could differ from these estimates.

Examples of significant estimates include:

• the allowance for doubtful accounts;

2. Summary of significant accounting policies (continued)

Financial instruments

The Synod initially measures its financial assets and financial liabilities at fair value. It subsequently measures all of its financial assets and financial liabilities at amortized cost.

Transaction costs related to financial instruments measured at fair value subsequent to initial recognition are expensed as incurred. Transaction costs related to other financial instruments are added to the carrying value of the asset or netted against the carrying value of the liability and are then recognized over the expected life of the instrument using the effective interest method.

3. Financial instruments

The Synod is exposed to various risks through its financial instruments and has a comprehensive risk management framework to monitor, evaluate and manage these risks. The following analysis provides information about the Synod's risk exposure and concentration as of December 31, 2022.

Credit risk

Credit risk arises from the potential that a counter party will fail to perform its obligations. The Synod is exposed to credit risk from members. In order to reduce its credit risk, the Synod reviews a new members credit history before extending credit and conducts regular reviews of its existing members' credit performance. An allowance for doubtful accounts is established based upon factors surrounding the credit risk of specific accounts, historical trends and other information. The Synod has a significant number of members which minimizes concentration of credit risk.

Liquidity risk

Liquidity risk is the risk that an entity will encounter difficulty in meeting obligations associated with financial liabilities. The Synod is exposed to this risk mainly in respect of its receipt of funds from its members and other related sources, contributions to the pension plan, and accounts payable.

Market risk

Market risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. The Synod is exposed to this risk in respect of its investment portfolio.

Interest rate risk

Interest rate risk is the risk that the value of a financial instrument might be adversely affected by a change in the interest rates. In seeking to minimize the risks from interest rate fluctuations, the Synod manages exposure through its normal operating and financing activities. The Synod is exposed to interest rate risk primarily through its cash equivalents and trust fund investments.

Unless otherwise noted, it is management's opinion that the Synod is not exposed to significant other price risks arising from these financial instruments.

The Synod has invested in the Consolidated Investment Portfolio, an investment fund managed by the Trustee Board of the Presbyterian Church in Canada. The Board acts as trustee of the Consolidated Investment Portfolio and monitors the investments in the fund for conformity to appropriate investment and Church policies.

The total investment made to the Consolidated Portfolio was \$250,000. The Synod contributed 36% (\$90,000) towards the investment, while the remaining 64% (\$160,000) was received from, and is invested in trust on behalf of Camp Geddie.

Any realized and unrealized income or losses during the year are allocated to each entity, consistent with the original investment allocation.

8. Pension plan

7.

The Synod is a member of The Presbyterian Church in Canada Pension Plan which was established to provide retirement income for eligible individuals. The plan is a contributory single-employer defined benefit pension plan. The Synod has accounted for this pension plan as a defined contribution pension plan because sufficient information is not available to use defined benefit plan accounting. The Synod recognizes the contributions required to be made under the plan as an expense. Total combined employer and employee contributions for the year were \$11,460 (2021 - \$12,204).

CAMP GEDDIE

Summary

It is easy for many of us to skim past the Camp Geddie reports, feeling it doesn't pertain to us and that we are disconnected from camp. However, camping ministry is a vital part of faith formation in 2023. I don't want to list off statistics, but I first want to ask you to reflect on the question "Did you go to Bible camp as a child or did/has your child, niece/nephew, or grandchild attend Bible camp". The odds are quite high that either you or a child in your life, attended a Bible Camp at some point in their life. And we may not realize the impact that attending camp has on the lives of children as they become adults.

While I did not attend Camp Geddie, I attended a Bible camp in Ontario. During staff training, as we sat in the outside chapel, I started singing songs I learned in the 1990s at Circle Square Ranch, and a few staff looked at me, bewildered. One of the staff quipped "I thought those were Geddie originals". I had not thought of those songs in years but sitting in a similar surrounding brought back all sorts of memories from my own camp experience as a 6-year-old, and I realized just how much of an impact that camp had on my life, even 30 years later. It's not just me- throughout the summer I spoke with many parents and grandparents who dropped off campers and took time to tell me about their own Geddie memories. Do not under value the role that Camp Geddie plays on the faith formation of our campers and their families.

Our camps include Breakfast, Lunch, and Supper, Morning devotion led by the chaplain, cabin Bible study, Canoe, Swimming, Games, Arts & Crafts, Nature, Sunporch Studies, Rest Period, tuck, evening sports, Night Devotion, Vespers, Evening Snack, and Camp Fire. During longer camps we also add a Sabbath morning with faith-based activities, Theme Day, Twilight (smaller camp fires), Picnic Supper, Talent Show, and a Cook-Out.

Overall, I can say the camp season was successful. It was not without challenges- Fiona, staffing shortages, and a power outage to name the biggest challenges, but those challenges also reminded me of a significant Bible verse in my life, James 4.8, "Draw near to God and he will draw near to you". With each challenge, I found myself facing the water, reciting that verse, and allowing God to take care of the rest. And with everything, God provided one way or another.

- Drinking Water: Geddie needs to replace its water filtration system. We were fortunate that Brita donated some coupons for filters and other members of the Geddie community donated funds for water as a temporary fix until the water system can be fully replaced.
- Power Outage: During Intermediate 2, following a storm, we lost power for 24 hours (a Geddie first!), staff were able to pivot and the power outage, while challenging, became a highlight for staff and campers.

Blessings

- We had no major injuries or illnesses this summer.
- Several campers came back for a second week after loving their first week.
- Several campers asked Helena for Bibles so they could learn more about the Bible during the school year.
- I had many parents reach out after camp to express gratitude for the camp experience as their children had good memories and stories to share with their parents.

Geddie Goals for 2024

- Revitalize the Camp Geddie Library, including having study Bibles available for campers who request their own Bible.
- Bring back TREC (an outdoor experience for older teens, this was requested by many staff)
- Replace the Water Filtration System
- Work on fixing the trails to pre-Fiona useability.
- Have mentors for our staff during the summer months.

Mission Committee

Mission is service, a call to help people in need and to permeate all of life with the compassion of God. *Living faith 9.1.3*

For the past few years the focus on Mission has changed from supporting a few endeavours to a wider mission across the Synod by supporting projects at the local level in Congregations

The Committee corresponded by e mail and zoom. After Synod last October and as Convenor of the Committee I contacted the Clerks of Presbytery in the Synod to seek a representative from their Presbytery to serve on the Mission Committee. There are still vacancies. New Brunswick was filled at the April Presbytery meeting.

The major item of business was to inform the Presbyteries of the money available for Mission projects across the Synod. Notices were sent out with an application form to the Clerks of the Presbyteries in the Synod.

Fourteen grant applications were received and sent to the Committee members. The Committee met by Zoom on December 7th 2022 to discuss the applications and to disperse the available funds. The requests were over \$20,000. The amount received from Synod was \$11,500. The following is a breakdown of projects funded.

ATLANTIC MISSION SOCIETY

The purpose of the Atlantic Mission Society (AMS) is to glorify God and support with prayer, study and service mission endeavours through The Presbyterian Church in Canada.

We are a group of women and men from the four Atlantic Provinces who have a heart for Christ's mission in the world. The AMS provides financial support to Presbyterians Sharing and PWS&D projects from the general Society level and from local auxiliaries. AMS members serve on national committees of The Presbyterian Church in Canada, including Assembly Council, Life and Mission Agency Committee, PWS&D and the International Affairs Committee as well as serving on Synod and Presbytery Committees and Synod Council. Members also work with, and support financially, one Synod and two Presbytery camps.

The AMS continues to publish *The Presbyterian Message*, with subscriptions going across Canada. The *Message* keeps its members connected with each other and the wider church with mission studies and news of mission oriented events happening locally, nationally and internationally. At the Annual Meeting in September 2022 it was decided to reduce the number of publications to five each year. Each publication will include two monthly devotions and two Prayer Corners. There will be no publication in July or August. The *Message* is also available electronically.

Joan Cho, the long-serving Editor of the *Message* will retire at the end of September, after our Annual Meeting. Joan has been an exceptional editor and those within the AMS appreciate her dedication, time and effort to produce a quality magazine each month. We wish her much joy in her retirement with her husband, the Rev. Dr. Stephen Cho, who recently celebrated 50 years of ordination.

The AMS is pleased to announce that the Rev. Dr. Marion Barclay will take over as Editor of the *Message*, upon Joan's retirement.

For the Mission Awareness Sunday, a service was prepared by members of AMS for use by auxiliaries as they lead worship on April 30, 2023.

The focus of AMS is shifting from doing the mission work itself, to educating and empowering the people of God so that congregations and Sunday Schools are encouraged and enabled to reach out with Christ's love. Many groups lead worship on Presbyterians Sharing and PWS&D Sundays, providing education for the whole congregation and arranging for opportunities for greater involvement in carrying out Christ's mission. Many AMS auxiliaries develop Lenten, Advent or other seasonal challenges to support the Canadian Food Grains Bank, Gifts of Change and other projects. The response from congregations and Sunday Schools is generous and positive.

Due to COVID-19, the Annual Meeting for 2022 was held using Zoom. The Annual Meeting for 2023 was hosted in person by Pictou Presbyterial at St. Andrew's Presbyterian Church in New Glasgow, NS from September 15–17th.

The guest speakers were Cathy Reid, President of the WMS. Her presentation focused on her recent trips to India and Malawi. Past President Rob Griffith spoke about his trip to Taiwan as part of the past Moderator Rev. Dr. Bob Ferris Moderator's trip. Rev. Ian Ross MacDonald, a member of AMS and General Secretary of LMA spoke about what is happening within the Presbyterian Church in Canada with regards to Missions.

The way we do mission work is changing, but giving thanks to God, and relying on the Holy Spirit to lead us, we continue to share Christ's love with the world.

Staff, campers, and parents were so excited for Camp to reopen. Staff worked hard all summer planning and participating in new games, bible studies, activities, and crafts. Our campers enjoyed our sports activities, the most favourite games played are always fireball,

soccer baseball, bump and campers vs. staff dodgeball. The campers also enjoyed partaking in crafts this year with Erin. Erin had different crafts every day for the campers to make, depending on the ages. Friendship bracelets, God's eyes, paintings, and puppets were among the camper's and staff's favourites. The campers and staff had a great time at the river this summer also. Maggie, our lifeguard, took the campers swimming 2-3 times a day depending on how warm the weather was. The campers enjoyed splashing around and jumping off the raft. Maggie and the staff did a great job at monitoring the campers and making sure everyone was safe swimming.

Since we were able to return to overnight camping since the pandemic started, we were happy to get back to our regular camp schedule.

Usually, every day at camp, if weather permitting, we follow the schedule above. If the weather is not cooperating, we substitute some outdoor activities for movie nights, dances, indoor games and vespers. Luckily we had really good warm weather, so warm that we were on a fire ban for most of the summer. That doesn't stop our staff and campers from singing campfire songs. We all still sat around the fire pit with our flashlights on singing the songs. Night Games are a big popular activity with campers. Campers love to play flashlight tag, Holy Grail,

Cities, and Counsellor Hunt. Our younger campers are not fond of the dark so we usually skip this part of the schedule for them and do another activity.

We always try to make the way we worship at Camp and learn more about his teachings fun, and interesting for the campers. A Lot of our campers are not part of the Presbyterian Church and most have had little experience with Faith, the Bible, and the teachings of the Bible. Before every meal, staff and campers stand behind their chairs and we pick out a grace to sing. All of our graces are sung in the tunes of popular children's songs and melodies. For example, a popular Grace we sing is the "Addams Family Grace", sung to the tune of the Adams family song;

Our devotional leader and staff try to make our daily bible studies relatable and engaging for the campers depending on the age groups. Jessica Breen, our Co-Director did a great job this year working on Bible Studies for the campers and developed meaningful and interesting bible studies for the Campers and Staff. Since a lot of our campers are new to bible studies our studies usually consist of relatable parables for certain age groups and the Gospel and Jesus's teachings. Peter MacDonald our board chairman helps the staff and devotional leader develop our bible studies on Staff weekends and throughout the summer. We also have an evening bible study that we call Vespers. Vespers usually consists of an opening prayer, bible story, song, and closing prayer. Every day a different group of campers are assigned roles in Vespers and read/sing the bible story/prayer/song for that day. We also worship the Lord at camp by being outside on his beautiful green creation, supporting each other, and helping others.

Camp MacLeod has positively affected the lives of so many people over the past 70

years. Whether campers came years ago or our 2022 season, they leave with a sense of comfort, friendship, and faith. Camp MacLeod has a good way of bringing people together and shutting out the busyness and distractions of the world. Summer of 2022 Reflection

At first, I was unsure on how this summer would go. I had worked in camps before and had attended many as a camper myself. Nevertheless, Camp Macleod was one of the few I hadn't. I was taking a break from the camp setting. I had been pursuing jobs that would pay more, all so I could support myself independently. This was not an easy decision as I had always loved being at camps and the fellowship that came with it. There's something great at work in these places. Camp was a place where people could come together and share memorable and shaping experiences. Camp had given me so much growing up. It gave me lifelong friends and memories. It taught me about kindness and love. It taught me to have an open heart and mind always. It gave me the strength and skills to be able to overcome many challenging moments in my life. I strongly believe camp shaped who I am today. Giving it up was one of the hardest decisions I might've made, because of how much it meant to me.

So, when it was suggested to me by a close friend of mine that had attended and worked there himself for years. I had gone on my computer that same day and applied. During all of this I had suffered an injury to my arm. I was on leave at my current job of that time. I had been at this job for almost two years at this point. It wasn't something I loved doing but I needed the money to get by. I was praying I would get the job at Camp. As it was something I really wanted and felt I needed to do. I needed a change. As soon as I heard word of my acceptance on the job, I had written up a resignment letter and dropped it off to my former manager. For the first time in a while, I was excited and

happy about what I was doing. It felt like the right thing to do. Little did I know that this would be one of the best decisions I've made in my life.

I was nervous at first, I had never been to Camp MacLeod before. I felt like I was starting from scratch. Even though I hadn't known most of the staff that I was working alongside, after a few days of working with them, it felt like I had known them for months already. It felt very natural, and our group complimented each other quite well. I remember having a conversation with Peter about how staff is the backbone of camp and is what really brings the camp together. I really couldn't agree with him more. I remember back when I was a camper and how much I looked up to my counsellors at the time. Being able to help guide and provide fellowship for these youth just as my counsellors had for me was an opportunity I am truly grateful for. My hope is that by the time each week ends these youth can leave feeling they've gained something from the experience. Whether that be friends, fellowship, memories, personal growth, or being able to have found a relationship with Christ. Camp is truly an amazing experience. Being able to work in this setting again is truly a gift that I am beyond grateful for. A teaching I was first introduced to from bible camp and that has stuck with me, reads this;

"We have different gifts, according to the grace given to each of us. If your gift is prophesying, then prophesy in accordance with your faith; If it is serving then serve; If it is teaching then teach; If it is to encourage then give encouragement; If it is giving then give generously; If it is to lead, do it diligently; If it is to show mercy, do it cheerfully." (Romans 12: 6-8).

These verses have stayed with me always. I find myself frequently going back to these words. They gave me guidance and still do. This is what I wish for our campers that come each year. I hope they can have something positive that will stay with them, even after they leave camp and return home.

APPENDIX D

SYNOD CAMPING STRATEGY

Historical Overview:

Camp Geddie:

In 1943, a special committee for Sabbath Schools and Young Peoples Society was appointed by the Synod to discuss the formation of a Synod Camp believing that camping was an effective means of Christian Education and spiritual growth for youth. The first Synod Camp was held at Camp Roderick at Sunnybrae, Nova Scotia in 1944. In that same year a former lobster factory/dance hall and 5 acres were purchased in Ponds, Nova Scotia (the heart of the current site of Camp Geddie). Children and youth attended from all over the Synod.

The ministry context of these decisions was a growing vision to augment the Sabbath School and Congregational youth programmes with camping experiences. That vision also gave birth to congregational camps throughout the Atlantic Provinces in places like Campbellton, Sunny Corner, and St. John, New Brunswick, St. John's, Newfoundland and Sunnybrae, Nova Scotia, to name a few. Presbytery camps also developed in Prince Edward Island and Cape Breton.

The facilities have seen significant development over the years with the building of individual and double cabins and the Margaret McDougall A Frame Lodge through the completion of the Irwin Lodge in 1989, a new crafts hall, a new washing facility, a new infirmary, new cabins, and a new marina to host the canoe programme. In 1990 an additional 10.5 acres were purchased.

With the completion of the winterized Irwin Lodge in 1989 a new phase of ministry was opened in winter retreats for organizations and congregations of the Synod. During this period and into the next two decades the focus of staffing at the camp changed. Young people, aspiring to further education were seeking paid employment and were not available for volunteer positions. Gradually government grants became available to assist with this expense but there was also a need to increase the financial commitment of the Synod to address this need.

In the late 1990's the need for an executive director was identified. This grew into an inclusion of this responsibility within the ministries of Synod Staff and eventually the Synod Youth and Camping Consultant.

Camp MacLeod:

It was during the post-war period (around 1945) that at least one minister in the Presbytery of Cape Breton advocated for a camp for Presbyterian young people within the Presbytery. By the early 1950s a camp was purchased from a Sydney service organization who had run the facility as a camp for under-privileged children. The first camp was held in either 1952 or 1953 under the Presbyterian banner. The camp has operated under the Presbytery of Cape Breton from its inception to the present.

A significant driving force for the creation of the camp was to provide a Christian camping experience for Presbyterian youth of the Presbytery that could be easily accessed. Realistically today, the campership, and staff, is made up participants from a variety of denominational backgrounds, and even no church background. Part of its current philosophy is to be an outreach in Christian community and faith to those who attend. We acknowledge the considerable financial support the Presbytery of Cape Breton provides for Camp MacLeod.

In these times few youth have available parents or guardians who are willing to drive to Camp Geddie from Cape Breton so this seems to be "a barrier" for participation at Camp Geddie.

Camp Keir:

Presbyterians have led the way in regards to camping ministry on the Island. While the Island currently has 5 Christian camps, Camp Keir is the longest running. It had its origins in 1947 when Rev. Jim McGowen, who was serving in Kensington at the time, bought some property in French River for the purposes of establishing a Presbyterian camp for our young people here on the Island. At the time, it was felt that sending our youth to Camp Geddie was not a feasible option for Island parents. The reasons for this were two-fold: first the travel and expense of transporting children back forth was unrealistic, and at the time Geddie was always running near full capacity.

As the years progressed, things began to change. A change in the ocean currents resulted in a much less appealing swimming situations and the numbers of those enrolling in our camps continued to decline.

These challenging circumstances caused presbytery to re-examine its camping ministry. It was proposed by some that a change of location might be the catalyst to breathe new life into our camping ministry. Land was purchased in Canoe Cove. During this period the Canoe Cove Church and the Charge of Central Parish really took hold of things and were integral in the operation and ongoing maintenance of the new building(s).

Funding and Accountability:

Camp Geddie:

The camp is owned and operated by the Synod of the Atlantic Provinces, with oversight provided by the Synod's Camp Geddie Committee, which reports to the Synod council and the Synod. The camp is accountable to the Synod, which receives annual reports of its ministry and finances. While funding for the camp comes from various sources the Synod does contribute a significant portion to support its camp.

Camp MacLeod:

Financially, each congregation is assessed by the Presbytery on a per household formula on an annual basis. There are also opportunities to make special contributions. The last several years the camp committee has initiated a pantry drive for designated food items. Last year there was a "wish list" circulated among the congregations for needed up grades to equipment at the camp. Some congregations provide camperships for their youth to attend; the camp does have a campership fund that was initially set up through a bequest at Bethel, Sydney. It is the Presbytery that oversees the operation of this camp.

Camp Keir:

The Camp does its own fundraising. Congregations are encouraged to support it as well by mean of fundraising and donations. We acknowledge the considerable financial support the Presbytery of Prince Edward Island provides for Camp Keir.

It is the Presbytery that oversees the operation of this camp.

Synod's Current Camping Strategy:

All the Camps within the Synod grew out of a calling to augment and support Christian Education among our young people. It is clear that while this focus on Christian Education continues, the camps note that this calling includes more than "our" Presbyterian young people as the camps offer Christian witness to young people from different denominations and from no church affiliation.

As stated in the historical overview the synod founded, and continues to own and operate, Camp Geddie to be a means of Christian education, spiritual growth and leadership training for our young people coming from various presbyteries, denominations and non-church back grounds within Atlantic Canada. The Synod also offers a camping experience to young people in presbyteries that do not have a presbytery camp. The Synod also offers an opportunity for young people to camp with people from other presbyteries, an experience which is continued in our synod youth events.

The Synod employs a Camping and Youth Consultant who serves as Executive Director of Camp Geddie to oversee and participate in the operation, administration, and promotion of the Synod Camp. The Executive Director provides direction and pastoral care to the campers and staff to promote the building up of young people in their relationship with Christ and each other. Given that it is not feasible in many cases for young people from PEI and Cape Breton to attend Camp Geddie these presbyteries have "filled a gap" by offering a more accessible means for Christian education through camping within their bounds. While Camp Keir and Camp MacLeod are not owned by nor held directly accountable to the Synod the Synod offers support to these camps recognizing their vital role in extending the camping opportunity in locations more accessible and feasible.

To offer support to Camp Keir and Camp MacLeod the Synod includes within its budget a grant for each camp. Furthermore, the Synod has assigned to its Camping and Youth Consultant the tasks of promoting camping ministry to the Synod, which would be inclusive of Synod and Presbytery Camps. The Synod also calls upon its Camping and Youth consultant to be a resource to Camps Keir and MacLeod and provide training.

APPENDIX E

MINISTRY DESCRIPTION Camping and Youth Consultant

(Adopted - 2021 Annual Meeting)

This is a full-time 3 year contract position which consists of two roles; I. Director of the Synod Camp, Camp Geddie and 2. Synod Youth Consultant.

The Duties of this position include:

I. Director of Camp Geddie:

- Oversee and participate in the operation, administration, and promotion of the Synod camp
- Serve as an ex officio member on the Camp Geddie Committee, and its subcommittees

(For details of duties and responsibilities see the Camp Geddie Committee: Job Description for Executive Director)

2. Synod Youth Consultant:

- Actively promote camping/and youth ministry to the Synod.
- Initiate and facilitate regular training opportunities for Children/Youth/Young Adult ministry leaders throughout the Synod (i.e. retreats, online meetings, webinars, guest speakers)
- Actively provide online resource materials and/or links to online resources through the Synod's website to aid congregations in developing their own Children/Youth/Young Adult and ministries.
- Work in consultation with the Synod's Programme Committee to:
 - o initiate, plan, and provide leadership for Synod Children/Youth/or Young Adult ministry events including PAYS
 - o provide oversight of booking, registration and transportation for participants to CY.
- Initiate regular contact with Presbyteries for the purposes of:
 - o Promoting/advertising Children/Youth/or Young Adult ministry events within the Synod, or within the larger national church (i.e. PAYS, CY, etc.)
 - Discerning together opportunities to share in initiating, planning, and leading Presbytery Youth Events
- Initiate personal contact with congregations for the purposes of:
 - Networking and fostering supportive relationships with local ministry leaders
 - discerning opportunities to assist with congregational Children/Youth/or Young Adult ministry events
- Initiate contact as a resource person to Camp Keir and Camp MacLeod for the purposes of helping to equip, support and train their staff
- To foster a relationship among the camps within the Synod

Education:

- University degree, preferably in a field relevant to the position.
- Theological education or other preparation for ministry within the Reformed tradition is required.
- Ordination or Designation to the Order of Diaconal Ministries is desirable, but a candidate with relevant qualifications and experiences who is prepared to function in a ministry role, subject to appropriate structures of accountability and disciplines, will be considered.
- Training and/or experience in Program Development.
- Knowledge of and compliance with The Presbyterian Church in Canada's policy to ensure the safety of children, youth and vulnerable adults ("Leading with Care")

Qualifications:

- Experience in camping and/or youth ministry leadership
- Self-directed, able to initiate and follow through on a variety of tasks
- Ability to work in a collegial way with others
- Strong interpersonal skills (including strong communication skills, conflict resolution, etc.)
- Ability to lead a variety of ages in a group task
- Skills in planning and time management
- Proficient in technology (i.e. web use, social media/networking platforms, etc.)
- Membership in good standing in a congregation of The Presbyterian Church in Canada, or on a Roll of a Presbytery (Qualified candidates from other branches of the Reformed Tradition may be considered)
- Knowledge of the polity and practices of The Presbyterian Church in Canada
- Complete and up-to-date Child Abuse registry and Criminal Record checks

Accountability and Consultation

- The Camping and Youth Consultant will be supervised by the Personnel Committee of Synod and will report to Synod Council through the committee
- The Camping and Youth Consultant will be an ex officio member of the Synod Programme Committee with voice but no vote
- If an Ordained Minister or Diaconal Minister, the Camping and Youth Consultant will be a member of the Presbytery in which she or he resides.
- The Camping and Youth Consultant will be expected to seek out and attend continuing education opportunities to remain up to date
- The Camping and Youth Consultant will be subject to an annual review of performance and ministry, conducted by the Synod Personnel Committee
- The Camping and Youth Consultant will be employed under the terms of the Human Resources Manual of the Synod

- Termination of the contract will be in compliance with the process outlined in the Synod's Human Resource Manual

Compensation:

This position is funded by The Synod of the Atlantic Provinces and its stipend and allowances are subject to the categories and rates of compensation regulated by the General Assembly's annual Minimum Stipend & Allowance Schedule.
